## Executive Summary

To advise Licensing Sub Committee Members of an application for the certification of numerous films in respect of the Leeds International Film Festival. All screenings are scheduled to take place between 3<sup>rd</sup> November 2020 and 19<sup>th</sup> November 2020 at Leeds Town Hall, Vue Cinema in the Light, and City Varieties.

A total of 62 films have been submitted requiring classification, however the applicant only has access to links for the viewing of 2 of those films. Following legal advice, Members are recommended to certify the films they cannot view as category 18 ratings and further information on this matter is detailed at 3.2 of this report.

### 1.0 Purpose of this Report

1.1 This report informs Members with the background, history and issues of an application made under the Licensing Act 2003 (“the Act”) for the certification of a film that does not currently have a BBFC (British Board of Film Classification) certification. Finally, this report informs Members of the options available to them when considering an application for the certification of films.

### 2.0 Background Information

2.1 The Licensing Act 2003 applies to premises which provide film exhibitions. At present there are a total of 8 cinemas licensed in the Leeds district.

2.2 The majority of films shown in cinemas will carry a certificate from the BBFC, the categories of which are as follows:



### 3.0 Main Issues

- 3.1 An application has been received from Leeds Film, Leeds City Council, to have a total of 62 films certified for the Leeds International Film Festival. The films are scheduled for screening between 3<sup>rd</sup> November and 19<sup>th</sup> November 2020, at Leeds Town Hall, Vue Cinema in the Light, and City Varieties.
- 3.2 In response to a briefing by the BBFC and advice sought from the council's Legal Department, it is essential the Licensing Sub-Committee can view each film in order to rate it appropriately. In instances where films are unavailable, Members are advised to certify them 18 rating, subject to a written declaration from the applicant conforming that each film does not contain any content which would more likely than not, render the film liable to be classified as R18 if considered in accordance with the BBFC Classification Guidelines. A copy of the e-mail from the applicant requesting the classification and including the declaration, can be found at **Appendix B**.
- 3.3 A list detailing the Title, Synopsis and the applicant's suggested rating of all 62 films, can be found at **Appendix C** of this report.
- 3.4 Details of the two viewable films, are as follows:

Title	Liz and the Blue Bird
Synopsis	An animated Japanese story about two girls in high-school who become close friends despite strong differences. Recommended certificate 12A.
Recommended Classification	12A

Title	Sun Children
Synopsis	Iranian drama about a group of street children who are recruited to find buried treasure below the local school. Includes moderate bad language and a brief reference to drugs. Recommended certificate 12A.
Recommended Classification	12A

- 3.5 A representative from Leeds Film is due to attend the hearing and provide additional details of each film.

### 4.0 Screener

- 4.1 The screeners for the two available films are not for public viewing at this stage. Members will therefore be provided with the screener link and access details in advance of the hearing to view the film.

5.1 There are no implications for Council policy and governance in respect of determining this application.

## **6.0 Legal and Resource Implications**

6.1 The applicant can appeal any decision made by committee. Any appeal would be to the Magistrates' Court.

7.2 Members are recommended to view films prior to the issue of a Certificate.
