**1. Purpose of this report**

- 1.1 This report presents information surrounding the refresh of the Future in Mind: Leeds Strategy and provides an opportunity for the Children and Families Scrutiny Board to input into the draft priorities proposed for the refreshed strategy, as developed from local data and the insight of children, young people and families.
- 1.2 During today's meeting, the Board will also receive a presentation from the NHS Leeds Clinical Commissioning Group (CCG) on how the future healthcare needs of children in relation to mental health, have been impacted by changes made to meet COVID-19 demand.

**2. Background information**

- 2.1 In November 2019, the Children and Families Scrutiny Board received an update on the Future in Mind: Leeds Strategy and Local Transformation Plan (2015-2020) setting out the city's vision, progress and next steps to improve the social emotional, mental health and wellbeing of children and young people aged 0-25.
- 2.2 At that stage, the Board acknowledged that during 2020/21, informed by the NHS Long Term Plan and the Leeds all age Mental Health Strategy, a new 5-year strategic plan would be created to continue the city's journey to improve children and young people's mental health and wellbeing in the city.

- 2.3 The importance of good mental health and wellbeing has continued to be acknowledged linked to the Scrutiny Board's ongoing focus surrounding the work of the Council and its partners in supporting all children and their families, especially the most vulnerable, during the Covid-19 pandemic.

### **3. Main issues**

- 3.1 The appended report from the Strategic Lead Commissioner, Children and Maternity, NHS Leeds CCG, provides information surrounding the refresh of the Future in Mind: Leeds Strategy and invites the Children and Families Scrutiny Board to input into the draft priorities proposed for the refreshed strategy.

- 4.1.1 The appended report outlines the continuous engagement of children, young people, families, and key clinicians and partners in the city, in planning and developing children and young people's mental health strategy, resources and services.

- 4.2.1 The appended report acknowledges that several key groups of children and young people have been identified as being at risk of experiencing poorer outcomes than the rest of the population. Whilst all of the priorities will ensure that these issues are addressed within the system developments, the identification of reducing health inequalities as a distinct priority area within the strategy will drive the particular focus on this.

Linked to this, improving social, emotional, and mental health and wellbeing for children and young people is one of the eleven priority areas of work identified within the Children and Young People's Plan.
