



We would like raise the following issues related to this application and PUBLIC NUISANCE:

There are <u>no major roads</u> linking this location, certainly not from the East as junction 46 of the M1 has no direct links to LS15 9AD, Junction 45 of the M1 links via Pontefract Lane which is basically a single carriageway road. The idea of having 20,000 capacity with a poor road infrastructure in the 2021 and over 4 days will only cause even more issues for residents and road users.

Junction 45 of the M1 is very busy at peak times 5 days a week due to the Park & Ride and now the Skelton Lake Services, Traffic will also very quickly back up on the the M1 slip roads on to the M1 carriageway causing PUBLIC SAFETY issues.

The residents of Swillington can already clearly hear events at Temple Newsam, particularly when continuing into the night, and this is planned to continue until 2am!! and is even closer to a residential area than Temple Newsam so the noise nuisance will be unacceptable, particularly for residents with children and also farm and domestic animals causing a PUBLIC NUISANCE.

The Leeds Festival used to be on the Temple Newsam site but that was moved <u>specifically for PUBLIC SAFETY issues</u> as fights broke out and tents were set alight, even with the agreed security that festival had in place.

There are no shops nearby and previous experience shows that Festival goers regularly leave the site to stock up on provisions and search for public conveniences. This will be a nuisance for the general public and residents gaining access to the local supermarkets.

The farm is very close to the M1 again causing PUBLIC SAFETY ISSUES for drivers being distracted by the lights and noise and for Festival Goers who may even attempt to walk cross the M1 carriageways, to get to the Motorway services.

This Festival has moved location on many occasions, almost annually , so that raises the issue of why ?? , presumably similar public safety, nuisance, crime and protection issues. It used to be at Lotherton Hall , also The Tetley , Stockheld Park and latterly Church Fenton and they were a shorter timescale and less numbers attending.

Not everybody attending camps and previous years many have stayed in local hotels which again will cause traffic and disruption issues for residents as the nearest hotels (apart from Skelton Lake services) are I presume Garforth and Crossgates.

Traffic using the M62 will completely block Woodlesford and Oulton and impact on Rothwell and Methley as again this road from the M62 is busy 7 days a week as again it is just a single carriageway, with very limited overtaking, popular with cyclists and walkers having to go under a low railway bridge not suitable for double decker buses and high vehicles.

No train stations nearby so again access for Festival Goers will be by road either cars, buses, taxis etc.

I work for the and once all this is over I m looking forward to a nice relaxing time spent in my garden, as are many of my elderly neighbours, and the last thing we need in September is a persistent noise and traffic nuisance







I would like to register my objection to any approval which might be given on the following grounds:-Public Safety The site lies on a narrow access road from Bullerthorpe Lane or directly from the A1/M1 Link motorway. The arrangements for vehicular access to the site are problematical due to a lack of footpaths and the consequence of queues forming on the motorway roundabout.

Public Nuisance Unlike festivals held at Temple Newsam where the sound was somewhat held in the 'bowl' of the grounds this proposed site is closer to the villages of Woodlesford and Swillington and the loud music will have a more direct transfer to these areas. Regarding the above application, I am concerned about the event for a number of reasons and would like to register my strong objection.

Given the fact that the attendance capacity for the first year (2020) is 14,999 and the second and subsequent years will increase capacity to 19,999 I am very concerned that there are likely to be problems with possible crime, public disorder, noise nuisance for local people and problems accessing the site.

In previous years, this event has caused controversy for the very reasons outlined above and it appears that the organisers have been required to find a new venue almost every year due to the same ongoing problems being repeated.

Examples cited following previous events include:

Behaviour which constituted public disorder, public nuisance, lewd behaviour, trespass and criminal damage.

The organisers having to surrender their licence after a North Yorkshire Police and Harrogate Borough Council review which cited problems including hundreds of people leaving the site on foot (which the organisers hadn't predicted) with some urinating and defecating in people's gardens.

Complaints from neighbouring residents due to the noise, lack of adequate transport, people walking in the road and sitting in their gardens. Claims from residents having to collect drug wrappers that they'd found on their properties, therefore exposing children to harm.

Based on this previous track record, I do not feel confident that the organisers would be able to prevent people leaving on foot if the festival was held at Newsam Green and would urge the Licensing Subcommittee to reject this application.

My husband and I live at a surriving to object to the granting of premises licence PREM/04519/001 to Newsam Green Farm, Newsam Green, Pontefract Lane, Leeds, LS15 9AD. There have been previous festivals and events in the area, and these are the problems which they caused:

- 1. Noise travels far in the countryside and we live less than 15 minutes' walk from the proposed site. Before moving to Bramham, the Leeds Festival was at TempleNewsam, further from our house than Newsam Green Farm, yet we could still hear every song clearly. Having this spread over 4 days and continuing until 2am is going to be unbearable. Of course, the noise will inevitably continue long after that.
- 2. Traffic is a major concern. Access to the farm is by a narrow road and the vast majority of vehicles will be funnelled through the A63 or the A642 leading onto Bullerthorpe Lane, from either the M1, A1, A1/M1 link or M62. The junction of Bullerthorpe Lane and the A642 is at the side of a bridge and there is a blind bend heading towards Rothwell. This is already a dangerous site, with numerous accidents having occurred there, some including fatalities. We have personal experience of just how bad it is, as my husband was involved in a multi-car pile-up that closed the junction, Bullerthorpe Lane and the A642 for hours and which forced him to take early retirement on health grounds. We have no doubt that the extra vehicles involved with opening up Newsam Green Farm as an event site will only worsen road safety in the area and increase congestion. During rush hour there are always queues in any case, and it is not unheard of for traffic heading onto the A642 from Bullerthorpe Lane to be backed up at least a quarter of a mile.
- 3. When the Leeds Festival took place at Temple Newsam, there was always an increase in crime and anti-social behaviour in the area. For example, one year the portaloos were set on fire, which resulted in the festival being no longer allowed to take place there. Local businesses were trashed; Sainsburys had baskets and trolleysstolen *en masse*, their toilets were smashed and flooded, and festival goers got drunk on their premises. The state of the site after the festival goers left was beyond appalling, with thousands of tents broken or burned, rubbish heaped up and/or burned, lots of people had gone to the toilet in bushes, and the grass was completely turned to mud.

Do we really want these sorts of additional crimes to take place in this quiet part of Leeds?

4. Where will all the festival goers stay? The first year there is to be no camping available. Even taking into account all the hotels and Airbnb properties in the area, there are insufficient places to stay. Does this mean that there will be a lot of rough sleeping?

Swillington is a quiet village in East Leeds, with a low crime rate. The only significant noise comes from the A1/M1, yet it used to be almost unbearable to live here when the Leeds Festival was at Temple Newsam. My husband and I do not want to see something similar happening again.

We write further to the above planning application and to detail our objections:-

1. Prevention of Crime and Disorder

No clear information on how the site will be policed in terms of substance misuse and drug dealing

2. Public Nuisance

Unfortunately I have been unable to find the map referred to in the text regarding traffic management and parking.

Since the road already has a prohibition of traffic at the Gamblethorpe (Road Traffic Regulations Act 1984 Sections 14 (1) and 15 (2) Road Traffic (Temporary Restrictions) Act 1991 we are concerned as to how the site will be accessed other than from Bullerthorpe Lane which is a totally inadequate road in extremely poor state of repair and would bring large volumes of traffic in close vicinity to the access to our homes. Additionally the road at both sides of the traffic lights are already subject to a large amount of fly tipping and particularly on Newsam Green Road, littering from the Colton Fast Food outlet all of which already of a huge impact on our home environment.

We envisage that the noise, volume of people and traffic in the area will be at a completely unacceptable level, however it is monitored. They may be able to monitor the noise on site but how is it to be monitored in the area around our homes which is normally a quiet peaceful setting. The layout of the festival stages and direction which the speakers are facing could also have a big impact on noise levels at our property.

3. Public Safety

The section of road between Newsam Green Farm and junction 45 of the M1 already has a huge volume of heavy vehicles due to the building of a new estate at the Skelton Gate site and the Biffa composting site. The restrictions of access at the traffic lights was imposed following several fatalities on what is a narrow and winding country road.

We are also concerned about the impact generally on the environment in what is quite a rural area. Generally how are age restrictions going to be monitored.

Our homes are also currently dealing with the Environment Agency on problems with odours from the Biffa composting site and the impact of HS2 on the area around our homes.

We appreciate we are in community of only 15 properties but we believe that the impact on us would be totally unacceptable if the licence is approved.

I wish to strongly object to the application for a premises licence regarding Mint Festival Ltd. – Newsam Green Farm, Pontefract Lane, Leeds LS15 9AD. REF: PREM/04519/001 for the following reasons;

This type of event is not for the benefit of the local community it is geared up purely for commercial gain. It would actively cause crime and disorder in the area, in terms of encouraging the sale of illegal drugs both inside and outside the event(s), as well as anti-social behaviour going on until the early hours of the morning on each day of the event(s).

It is well documented that the sale of alcohol (and drugs) during the extended hours of 12.00 and 02.00 would require extra Policing and put a strain on local hospitals and increase the threat of violence erupting at the event(s) and disturbing the peace of local residents in the surrounding area.

Large numbers of people descending on a green belt area, would almost certainly create a public nuisance, due to all the associated litter left behind thus, encouraging the spread of vermin which would have an adverse affect on public safety and public hygiene in the area.

Furthermore, such an event would mean residents in the area would suffer loss of amenity during these events, in terms of being unable to enjoy the peace and tranquillity of their own garden due to the noise pollution created by the event. Why should the public have to put up with a noise party that would go on for several days and nights at a time.

Granting a licence, would further attract the potential for more crime to be committed in the local area for example, shop lifting in local shops, trespassing on peoples land, using local residents land as public toilet areas and a whole host of other issues.

In addition, more climate pollution would be generated due to the additional volumes of traffic coming into the area to attend the event(s). Leeds City Council - I believe are committed to reversing climate change rather than increasing it. Increased air pollution is a detriment to public health and harmful to children living in the surrounding area.

The Pontefract Lane area of the City and in particular, the roads surrounding this farm are narrow country lanes, which could increase the risk of road traffic accidents occurring, with all the extra volumes of road traffic such events would bring. This would also create a nuisance for local farmers in the area who need to access their fields for work purposes.

If a licence was to be granted for this type of event, it is an active invitation to terrorists and presents a serious public safety risk to all those attending the event. There is a perfectly adequate licenced music arena in the City of Leeds for such events. The arena is properly controlled with security and cameras for the safety of the public in general and to reduce the terror threat.

This is also an abuse of green belt area purely for commercial gain. If the weather happened to be very inclement over the day(s) of these events, it would turn a green space into a mud bath which would be trailed out onto the roads creating road safety hazards, given vehicles would not be able to brake safely with all the mud covering the road surfaces.

There is also the safety of local farm animals at risk, in respect of the large volumes of traffic and people coming and going. Causing upset to the animals and disturbing local wildlife.

Who will enforce the no camping rule during the first festival, there is likely to be tents pitched all around the area on privately owned land, in order to get in early to the festival to obtain the best viewing spots.

I do hope the Council licencing authority will take full account of my objections, and no doubt the objections of other local residents, by <u>refusing</u> to grant a licence for these events both now and in the future.
