Thanks for the points outlined below. My comments are as follows:
• The access for all vehicles to the site is from Pontefract Lane via the roundabout at Junction 45 of the M1. Public parking and taxi/public pick-up/drop-off (PUDO) will be via Gate 2 with the exit back to J45. MiNT taxis and shuttle buses will use Gate 1 and will exit via Bullerthorpe Lane. There is no detail on how Gate 2 will be arranged to allow MiNT taxis and shuttles through to Gate 1 with other PUDO leaving Gate 2 to reach J45 – Public SafetyTwo qualified traffic management operatives based at the closure point outside gate 2. They will help with traffic flow and only be allowing shuttles and Mint taxis through the road closure point to gate 1.
o Queuing capacity between J45 and Gate 2 needs to be assessed to ensure that there is no queuing permitted back to the roundabouts – Public SafetyWill apply for Matrix signs advising of delays and involve Highways England emergency planners of the event so they are aware. Response vehicle along Pontefract Lane to the site to assist keeping vehicles moving and identifying problems early to resolve sooner. Not many vehicles expected to park on-site so quick turn around of vehicles during the day will keep the traffic moving.
o The access to the new services will need to be maintained at all times and liaison with them to prevent festival parking taking place thereTwo road warning signs will be placed outside the entrance to the services to warn people not to park otherwise fines will be issued.
o Safety of pedestrians leaving the site – the plan indicates a safe walking route along Pontefract Lane. The routes beyond that, both directions away from the site, need to be assessed and addressed. Regardless of statement that they will encourage use of taxis/shuttle buses, previous experience has shown that attendees will walk to/from the event – Public SafetyLike any event, we can't stop people from walking but we can provide a designated safe walking route available from the event site to Leeds via Temple Newsam. Floodlights and security stewards will be located at key points to ensure public welfare and safety.
♣ Bullerthorpe Lane is a 60mph unlit highway without a continuous footway system and is not suitable as a walking route, especially during hours of darknessAgreed, we can't stop this but event organisers will deploy security to help prevent.
• The route directing non-motorway traffic does not prevent shorter routes via Halton Moor, Osmanthorpe Lane or East End Park. However, it would be expected that the majority of traffic wold use the M1 rather than this routeRoad signage will be in place to direct traffic to use key routes.

Hi Andrew,

Hope you are well.

- There is a Clearway in force on East Leeds Link. The organisers need to be alert to prevent any parking taking place to avoid an enforcement requirement Public Nuisance. Noted, we can't stop illegal parking but normal procedures via police for removal or Parking enforcement for ticketing via Leeds CC.
- Concerns raised at the site meeting regarding the potential for drivers to drop passengers off on the M1 hardshoulder adjacent to the site need to be addressed. The only reference to the M1 is that there will be no temporary signs will be plced on the motorway. Highways England and their agent need to be involved in the planning Public Safety. -Unlikely to happen as the venue cant be seen from the motorway but it has been noted. Matrix warning signs will keep vehicles moving. I will be in contact Highways England to resolve.
- No information regarding the city centre part of the shuttle operation is in the TM Plan or the Event Plan. It should be noted that this event will be during the football season and that the coach provision at Sovereign Street will be used by football shuttles if there is a match at Elland Road on that date. Clearly at the current time we are not able to confirm arrangements. -Not sure on fixture dates yet.
