2. Please provide a brief description of what you are screening

In 2014 Leeds City Council commissioned two organisations to deliver HIV prevention and sexual health promotion activities and weekly community testing: Black Health Agency (BHA Skyline) to work with Black African communities and Mesmac to work with men who have sex with men (MSM). Activities include group sessions, 1:1 support, peer support, testing for HIV and other STIs, and distribution of condoms.

The contract includes provision for 4 x 12-month extensions, two of which have been used, with the current extension expiring on 31st March 2021.

The need in the city has changed since the contract was put in place and it is therefore necessary to review the scope of this provision and its target communities to ensure that we are directing resources where they are most needed. Approval is therefore being sought to extend these contracts for one year, during which a service review and re-procurement exercise will be undertaken. As a continuity of existing provision, there are no new impacts on any groups.
