Summary

1. Main issues

- This funding was originally funded by the West Yorkshire & Harrogate Local Workforce Action Board to fund a West Yorkshire and Harrogate public health workforce development post (started Feb 2019 and left the post Feb 2020) and a separate WY&H collaborative workforce development project to work across the WY&H ICS footprint (funded for 12-18 months from Sept 2019).
- The above project has had to pause due to the post holder leaving and as a result of COVID-19, both the underspend from the post becoming vacant and the project not being led by Leeds City Council there is a need to return the remaining funding to WY&H ICS
- The total funding to be returned is £126,383; as this was funding to work across the WY&H ICS footprint it has no direct impact on Leeds City Council; and it is no longer appropriate for the budget to be held by Leeds City Council - Public Health

1.1 To purpose of this report is to seek approval to return Local Workforce Action Board funding to West Yorkshire and Harrogate ICS (via Wakefield CCG) due to the regional post no long hosted by Leeds City Council

2. Background information

2.1 This funding was originally funded by the West Yorkshire & Harrogate Local Workforce Action Board to fund a West Yorkshire and Harrogate public health workforce development post (started Feb 2019 and left the post Feb 2020) and a separate WY&H collaborative workforce development project to work across the WY&H ICS footprint (funded for 12-18 months from Sept 2019

3.1 £126,383 non recurrent funding was given to Public Health to fund a Workforce Development post for 18 months. Due to the post holder leaving the role and COVID, the project was paused. Due to both the underspend from the post becoming vacant and the project not being led by Leeds City Council there is a need to return the remaining funding to WY&H ICS
