2. Please provide a brief description of what you are screening

The decision is for permission to procure an Electronic Market Place (EMP) for Independent Schools and Colleges for children and young people with Special Educational Needs and Disabilities (SEND). Education and Education and Residential Care placements with external providers will be commissioned via this contract.

The contract is commissioning via the White Rose partnership. A collaboration between fourteen Local Authorities and one Children’s Trust in the Yorkshire and Humber region working together to commission external placements in order to improve quality and value for money.

The current contract expires on 30th June 2021 and the decision is to competitively tender for a EMP for SEND placements to be in place from 1st July 2021. This work has been informed by a review which included engagement with local authorities across the region in addition to health colleagues, parents and carers, young people and providers.

Some face to face engagement towards the start of the review took place but the majority of the engagement took place via online surveys and virtual meetings

If a suitable placement cannot be found from within the SEND EMP then it can be sourced outside the agreement.
