b) The prevention of crime and disorder

I have ran a licensed fish and chip shop in Consett Co Durham for the last 2 years and also assisted in the running of a night club as I am also a qualified Licensed Door Supervisor by the sia so I am aware of the responsibilities associated with selling of alcohol and the duties I need to ensure to keep everyone safe and prevent any disorder.

c) Public safety

As above I am aware of the need to keep the members of the public safe and out of harms way. The sia training also taught this. As we have CCTV in operation we can monitor and record instances of any abuse and public safety within the premises.

d) The prevention of public nuisance

We have CCTV in operation in the shop at all times to help monitor any public nuisance and the shop will have a new entrance with additional CCTV cameras. This will allow for a safer and more lit up area which will protect customers and staff while deterring potential disturbances.

e) The protection of children from harm

Again with the sia training we are made aware of when children are showing signs of harm or abuse and I will be very vigilant of that. We have CCTV in operation at all times so can monitor any patterns etc but in addition we will install CCTV outside the building at the entrance which will be constantly be monitoring activity.

 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
