2. Please provide a brief description of what you are screening

Phase 2 of the Leeds Pipes District Heating Network will see the underground pipework extend directly into the city centre, so that low carbon heat can be supplied to a greater number of customers and the benefits of the network can be maximised. The network extension is being constructed under the terms of a NEC3 contract and as such there is a requirement for the NEC3 roles of Project Manager and Supervisor to be filled.

During the construction of Phase 1 of the network, Ove Arup & Partners Ltd provided technical support to the council and also acted as Project Manager and

Supervisor. This ensured sufficient specialist technical support was in place to ensure the successful construction of the network.

It is proposed that Ove Arup & Partners Ltd provide the same technical support for the phase 2 extension, acting as PM and Supervisor. As such a new contract is to be awarded using the same terms as the initial contract. Once signed, the contract will be novated from the council to Leeds PipeCo Ltd, who own the phase 2 DHN assets and who have the construction contract with construction contractor.
