#### Summary

#### 1. Main issues

- The Council has received an application for the re-designation of Hyde Park Neighbourhood Forum. The neighbourhood forum application covers the Hyde Park Neighbourhood Area, which remains unchanged.
- The original forum designation was made in September 2015 and lasts for a period of 5 years. Hyde Park Neighbourhood Forum wish to renew the designation to enable them to proceed with the plan through to examination and referendum, and to assist with the implementation of the plan once it has been made.
- The application was publicised and representations invited for a period of 8 weeks between 14 October and 9 December 2020, 12 representations were received.
- The Hyde Park Neighbourhood Forum are at an advanced stage and are preparing to conduct pre-submission consultation on their plan once the forum re-designation has been approved.

#### 2. Best Council Plan Implications (click here for the latest version of the Best Council Plan)

 Neighbourhood planning helps to deliver on the ambitions of the Best Council Plan by enabling local communities to have a voice in shaping the future growth of their areas. It provides the opportunity to identify and plan for the future sustainability of an area by preparing locally-distinctive planning policies which will be used by the Council to help determine planning applications in a given area and by setting out projects and aspirations.

# 3. Resource Implications

- The Council has already claimed £10,000 for the designation of the Hyde Park Neighbourhood Area and Forum. There is no additional funding available for the redesignation but the costs associated with this are minimal and can be accommodated within existing budgets.
- The Council will be able to claim £20,000 once the neighbourhood plan has been successful at examination and a date for the referendum has been set.

#### Recommendations

- The Chief Planning Officer is recommended to:
- **1.** Re-designate the Hyde Park Neighbourhood Forum for the Hyde Park Neighbourhood Area.

# Purpose of this report

1.1 This report seeks approval for the re-designation of the Hyde Park Neighbourhood Forum.

# 2. Background information

- 2.1 The Neighbourhood Planning (General) Regulations (2012) (as amended) specify what should be included in neighbourhood forum applications (and applications for re-designation):
  - The name of the proposed neighbourhood forum;
  - A copy of the constitution of the proposed neighbourhood forum;
  - The name of the neighbourhood area to which the application relates and map which identifies the area;
  - The name and contact details of at least one member of the proposed neighbourhood forum; and
  - A statement which explains how the proposed forum meets the conditions as set out in the Town and Country Planning Act (1990)
- 2.2 The Act states that local planning authorities may designate a neighbourhood forum if they are satisfied that:
  - It is established for the express purpose of promoting the economic, social and environmental wellbeing of an area that consists of or includes the neighbourhood area;
  - Its membership is open to:
    - o Individuals who live in the area;
    - Individuals who work there (whether for business carried on there or otherwise);
    - Elected Members
  - Its membership includes a minimum of 21 individuals who meet the above criteria; and
  - It has a written constitution.
- 2.3 If a neighbourhood forum designation is made, no other organisation or body can be designated for the same neighbourhood area (until the designation expires or is withdrawn).

# 3. Main issues

# The Neighbourhood Forum Re-designation Application

3.1 The neighbourhood forum re-designation application (available at appendix 1) meets the criteria as set out in the Neighbourhood Planning (General) Regulations (2012) (as amended) and officers are satisfied that it meets the conditions set out in Section 61F of the Town and Country Planning Act (1990) (as amended).

# **Publicity of the Neighbourhood Forum Application**

- 3.2 The Neighbourhood Planning (General) Regulations 2012 specify that the local planning authority must publicise on its website and in other such manner as to bring the application to the attention who live, work or carry out business in the neighbourhood area:
  - A copy of the application;
  - A statement that if a designation is made no other organisation or body can be designated for the neighbourhood area;
  - Details of how to make representations; and
  - The date by which those representations must be received (minimum of 6 weeks).
- 3.3 The neighbourhood forum re-designation was publicised between Wednesday 14 October and Wednesday 9 December 2020.
- 3.4 The application was on the Council's Hyde Park Neighbourhood Plan webpage: <a href="https://www.leeds.gov.uk/planning/planning-policy/neighbourhood-planning/hyde-park-neighbourhood-plan">https://www.leeds.gov.uk/planning/planning-policy/neighbourhood-planning/hyde-park-neighbourhood-plan</a>. Due to Covid-19 restrictions paper copies could not be made available, but site notices were placed around the neighbourhood area giving details of the publicity, information on how to view the documents and a QR code signposting to an online survey providing the opportunity to respond to the consultation. There was also an option to discuss the application with the Council's Neighbourhood Planning officers over the phone.
- 3.5 The publicity of the neighbourhood plan met the requirements of the Regulations.
- 3.6 12 representations were received, including 9 responses to the online survey. 3 responses made no comment on the re-designation, 2 responses objected to the re-designation and 7 supported the re-designation (see appendix 2).

# **Progress of the Hyde Park Neighbourhood Plan**

- 3.7 The neighbourhood forum have worked positively and collaboratively with the Council to prepare the neighbourhood plan. The group has a high capacity to prepare the neighbourhood plan and forum meetings are well-attended by local residents and businesses.
- 3.8 It is expected that formal pre-submission consultation will take place on the draft plan during the course of 2021.

# 4. Corporate considerations

# 4.1 Consultation and engagement

- 4.1.1 The application was published on the Council's website and within the Hyde Park Neighbourhood Area in line with regulatory requirements.
- 4.1.2 The draft neighbourhood plan has been informed by a programme of engagement and consultation. Consultation will take place on the pre-submission draft plan in due course.

- 4.1.3 Ward members for Headingley & Hyde Park and Little London & Woodhouse wards have been consulted on the re-designation of the neighbourhood forum.
- 4.1.4 Councillor Mulherin has been consulted on the re-designation and this report.

### 4.2 Equality and diversity / cohesion and integration

4.2.1 The Government has undertaken an Equalities Impact Assessment of the Localism Act in relation to neighbourhood planning (2011). The Council views the neighbourhood planning process as an opportunity to deliver equality, diversity, cohesion and integration objectives.

#### 4.3 Council policies and the Best Council Plan

- 4.3.1 Neighbourhood planning helps to deliver the ambitions of the Best Council Plan by giving local communities the opportunity to directly shape the future of their local areas. It meets the Best City Priorities in a number of ways, for example:
  - Health and Wellbeing: neighbourhood plans can address health and wellbeing through exploring green space and green infrastructure issues and including urban design principles;
  - Sustainable Infrastructure: neighbourhood plans can identify opportunities to improve physical and social infrastructure and include projects to implement those improvements. in addition they can shape green / blue infrastructure design and delivery;
  - Child-Friendly City: neighbourhood plans can identify sites for new play
    provision, improve connectivity to existing play provision and can help to
    ensure new development facilitates children's play and activity;
  - Age-Friendly Leeds: neighbourhood plans can help older people to remain in their communities by encouraging new provision of housing suitable for elderly people or by identifying sites for new development;
  - Culture: neighbourhood plans can help to protect existing cultural and community assets and facilities. In addition, they can identify areas of special historic / cultural character for consideration in the planning process and nominate non-designated heritage assets to the Council for inclusion in a Local Heritage List;
  - Housing: neighbourhood plans can identify and allocate sites for housing development to meet local needs and can shape the delivery of the Council's development allocations;
  - Safe, Strong Communities: neighbourhood plans can help to build local capacity and community cohesion by bringing together residents, businesses and other stakeholders to prepare a vision for their area; and
  - Inclusive Growth: neighbourhood plans can be used to bid for funding for local projects which are important to the local community, they can also influence the spending of the neighbourhood portion of the Community Infrastructure Levy.

#### **Climate Emergency**

- 4.3.2 Neighbourhood plans must contribute to the achievement of sustainable development and can help mitigate against the effects of climate change. In particular, they can shape how blue / green infrastructure is delivered and identify links and networks, identify sites that extend habitat networks, promote active travel, and support new development that is of a high quality and sustainable design.
- 4.3.3 The declaration of the Climate Emergency in 2019 has boosted interest within local communities in planning and development issues. Neighbourhood planning groups are being encouraged to play an active role and to include policies and projects which respond positively to climate change issues.

# 4.4 Resources, procurement and value for money

- 4.4.1 The City Council has claimed the full grant funding available to local authorities from DCLG to help cover the cost of designating neighbourhood areas. The Council will be eligible to claim £20,000 when the neighbourhood plan has passed the independent examination and a date for the referendum has been set.
- 4.4.2 The Council has a statutory Duty to Support neighbourhood planning groups and must undertake a number of statutory responsibilities during the neighbourhood planning process, as follows:
  - The designation of the neighbourhood area;
  - The designation of the neighbourhood forum (where relevant);
  - The publication of the neighbourhood plan once it has been submitted for independent examination;
  - To organise, manage, and pay for the independent examination;
  - To organisation, manage, and pay for the referendum; and
  - The formal assessment of the neighbourhood plan against EU regulations.

# 4.5 Legal implications, access to information, and call-in

- 4.5.1 Neighbourhood planning is taking place within a new and fast-changing national planning background which is focussed on economic growth, localism and sustainability. The Council adopted its Core Strategy in November 2014 and the Leeds Site Allocations Plan was in 2019. The Core Strategy Selective Review was adopted in 2019.
- 4.5.2 The Council is responsible for ensuring that a neighbourhood plan has been prepared in accordance with relevant legislative requirements.

#### 4.6 Risk management

- 4.6.1 The examination and referendum process introduces risks in the neighbourhood planning system where the outcome will be dependent on the examiner's recommendations and a public vote.
- 4.6.2 There are risks that
  - the plan will not receive more than 50% 'yes' votes in the referendum

- the plan will be the subject of a legal challenge or judicial review
- 4.6.3 The Council will work closely with the neighbourhood forum to manage and minimise these risks.

#### 5. Conclusions

5.1 The Council accepts that the Hyde Park Neighbourhood Forum Designation application meets the relevant legislative requirements and agrees the redesignation of the Hyde Park Neighbourhood Forum for the Hyde Park Neighbourhood Area.

#### 6. Recommendations

- 6.1 The Chief Planning Officer is recommended to:
  - a) Re-designate the Hyde Park Neighbourhood Forum for the Hyde Park Neighbourhood Area.

#### 5. Statement.

This section provides the opportunity to set out the purpose, aims and ambitions of the neighbourhood forum and to demonstrate how its membership is representative of the local community.

In order for the City Council to designate a neighbourhood forum to act on behalf of a neighbourhood area, it needs to be satisfied that the following conditions contained in Section 61F (5) of Schedule 9 of the Town and Country Planning Act 1990 (as amended by the Localism Act) are met:

- a) it is established for the express purpose of promoting or improving the social, economic and environmental well-being of an area that consists of or includes the neighbourhood area concerned (whether or not it is also established for the express purpose of promoting the carrying on of trades, professions or other businesses in such an area)
- b) membership is open to and includes a minimum of 21 individuals each of whom:
  - live in the neighbourhood area;
  - work in the neighbourhood area;
  - carry out business in the neighbourhood area (for example, represent the area as a local councillor or as a Member of Parliament.
- c) it has a written constitution (as detailed in Section 2)

Please set out the purpose, aims and ambitions of the proposed neighbourhood forum here:

The purpose, aims and ambitions of the Hyde Park Neighbourhood Forum remain the same as when the Forum was initially set up. The key ambitions for the Forum are as follows:

Our ambition is that people, groups, businesses, people living or working in our area and others with an interest in our area will all work together in strong and cohesive way, to:

- Be a strong and cohesive local voice which can effectively represent us and shape the future of our area.
- Ensure that there is a good mix of accommodation types available to people locally including homes for families with children and older local residents, to restore the demographic balance which has affected the area and the community severely over the last twenty years.
- Promote demographic balance in the area (because of the position of the neighbourhood in relation to the city) by developing the neighbourhood as a walk to work zone and renovating accommodation to attract long term residents.
- Recognise and work to reduce the serious nature of noise pollution. This is not a nuisance but a serious disturbance of the peace and must be tackled.
- Produce a strategy for dealing with rubbish in the street which is a serious environmental hazard and health risk.
- Recognise the contribution of local businesses and organisations within the area and enable them to have a voice contributing to the improvement of the area.
- Seek to find ways to improve our built environment including improved maintenance of properties within the area, external aspects, including gardens, as well as internal, through greater regulations of landlords.
- Develop a strategy for buying back existing properties, renovating and restoring them, to be re-sold back to longer term residents, rather than building new ones.
- Develop a strategy to diversify use of current housing stock to meet local needs.
- Retain, restore, protect and extend our green spaces for all members of the community whilst maintaining biodiversity.
- Better promote the unique character and advantages of the area to residents, potential residents and visitors.
- Harness our community and cultural assets and local talents to enhance our existing cultural hub.
- Harness the potential of the Universities in relation to the cultural possibilities of the neighbourhood and also economic innovation and business potential.
- Improve the infrastructure of the area, such as, better facilities for families, sports and leisure facilities, measures to reduce traffic, waste collection, and cycle paths and footpaths through the dense residential areas.
- Better meet the needs of all sections of our community by increasing the range of local facilities and protecting and promoting local employment.

The Hyde Park Neighbourhood Forum was initially set up in 2014 and formally designated as a Neighbourhood Forum on 17th September 2015. Since then, the Forum has worked to consult and engage with residents, businesses and other stakeholders in the Hyde Park area.

# **Summary of Engagement**

- 2012 2014: early stages of neighbourhood planning including capacity building within the local area and discussions with community groups and other stakeholders about neighbourhood planning and preparing the neighbourhood area and forum designation applications
- 2015 and 2016 involved us gathering evidence about key issues and options for the area and consultation and engagement events

- 2017 saw the plan-preparation stage where our policy intentions document started to be put together
- In the summer of 2018 the forum undertook informal consultation on our policy intentions

Taking all of the engagement work into consideration, a Policy Intentions Document was prepared with consultancy support and support from members of the neighbourhood planning team at Leeds City Council. An informal round of consultation took place on the policy intentions document took place in Summer 2018. Work to progress the Policy Intentions Document into a Pre-Submission Draft Plan stalled between 2018 and Summer 2020, however through discussions with LCC NP officers and within the Forum, a project plan and series of actions have been agreed to create a pathway for the plan to progress to examination and referendum. The pathway is set out at Appendix 3.

Following discussion with the Headingley Neighbourhood Forum over the boundary of the neighbourhood area, it was jointly agreed that both the Hyde Park Neighbourhood Forum and the Headingley Neighbourhood Forum would concurrently apply to re-designate their respective neighbourhood areas to accommodate the transfer of Little Moor from the Headingley Neighbourhood Area to the Hyde Park Neighbourhood Area. This would have the effect of ensuring that the whole of Woodhouse Moor falls within the Hyde Park Neighbourhood Area. The revised neighbourhood area designations were made on 24<sup>th</sup> October 2018. This forum application is for the neighbourhood area as designated on that date.

Throughout the 5 year period, the Forum has met regularly to steer the progress of the plan and also to provide space to local residents, businesses, community organisations and others to discuss local issues, collaborate and work on community projects. The redesignation of the forum will help to re-invigorate the group to focus on making timely progress to pre-submission consultation and then on to independent examination and referendum. It is expected that the Forum will continue to provide a voice for local residents and other stakeholders to engage with community issues during this time and after the plan has been made.

The Forum currently has 150+ members representing residents, businesses, community organisations and other stakeholders in the neighbourhood area. Elected Members for the Headingley and Hyde Park Ward and Little London and Woodhouse Ward are also active members of the Forum. Communication mainly takes place via email (particularly since the outbreak of Covid-19). Membership is open to all who live, work or carry out business in the neighbourhood area, and the express purpose of the Forum is to continue working on the neighbourhood plan for the area and to promote the social, economic and environmental well-being of the area.

The Neighbourhood Forum is structured in order to optimise the involvement and commitment of people with a genuine interest in protecting and improving our Area. The Hyde Park Neighbourhood Forum will, therefore, be a 'Relevant Body' for the purposes of section 61G(2)(b) of the Act since, in accordance with the Act, it is 'capable of being designated as a neighbourhood forum (on the assumption that, for this purpose, the specified area is designated as a Neighbourhood Area)'.

Our neighbourhood plan will represent the views or our community to support the sustainable development of our area in line with our ambitions as stated above and in accordance with our constitution. The collaborative relationship that we have established with Leeds City Council will be critical to the success of the plan and of our wider ambitions. It is expected that this positive working relationship will continue.


