This proposal will call off from a third party framework to direct award to a single supplier for a contract commencing 01/04/21. The contract will provide Class 1 domestic heating materials (including boilers, radiators etc.).

The value will be approx. £4 million per annum. The contract length will be 2 years plus 2 x optional 12 month extensions (2+1+1) to align with the current Servicing contracts.
