	There is extremely limited space currently available at Little Owls Firthfields for				
	activities other than childcare. Family services for Garforth are therefore				
	delivered from Garforth Academy within the main building which incurs a cost. This causes barriers for the families needing to access the services and there is				
	no outdoor provision there for stay and play. The space at the academy is				
	limited and there is also no prospect for effective co-location of 0-19 services				
	such as midwives or health visitors. The Academy also wish to expand school spaces into the area currently used by the Children's Centre.				
	Figures from the sufficience	cy report, shows a sustained	d increase in private		
	provider places in Garforth whilst Firthfields Little Owls Nursery has showed				
	a sustained decline in take up of places. There are 5 full day care nurseries within 2 miles of Little Owls nursery and 3 primary schools which means that				
	0-5 places in Garforth are over provided for the number of children in the				
	area.

	A number of reviews took place to ascertain if the centre could be kept open as a nursery. Different configurations were considered including term time only provision and a change to hours of operation. The result of the review confirmed that the childcare was surplus to requirement in the area and that changing the business model could not bring about an improvement because there were insufficient children to fill the places available in the area already provided by the market.
