

## REGISTER OF GIFTS AND HOSPITALITY RECEIVED BY MEMBERS OF LEEDS CITY COUNCIL

The Leeds City Council Member’s Code of Conduct provides at paragraph 11:-

“You are also required to notify the Monitoring Officer of any gifts or hospitality with an estimated value of £50<sup>1</sup> which you receive in your role as a Leeds City Councillor<sup>2</sup>. You must inform the monitoring Officer of any such gifts or hospitality within 28 days of receiving them so that the details can be entered into the Register of Interests<sup>3</sup>.”

The table below therefore sets out details of gifts and hospitality received by Leeds City Councillors and notified to the Monitoring Officer within the last two years.

<sup>2</sup> This does not apply to events or hospitality given by the Council and does not include civic gifts or hospitality received by the Lord Mayor of Leeds whilst acting in this capacity. Civic gifts are to be recorded in a separate register maintained by the Lord Mayor’s office.

<sup>3</sup> These details will be removed from the register by the Monitoring Officer two calendar years after they were received.
