Aspire employs approximately 800 staff of which 72% are former Council employees who have retained their Leeds City Council terms and conditions. Aspire Services (Leeds) Limited have a block contract with the Council for the above provision, but have also secured additional business in relation to one to one support and new services which have been recently developed. The block contract was originally issued for five years from 1st August 2015 to 31st July 2020. The contract contains provision for one 12 month extension period, which has been invoked, resulting in an end date of 31st July 2021.
