## 2. Please provide a brief description of what you are screening

This screening is for a Delegated Decision Report to the Director of Adults and Health, requesting approval to vary the contract awarded to Aspire Services (Leeds) Limited for 12 + 12 months through the modification of the contract during their term under Regulation 72 (1b) (i) & (ii) of the Public Contract Regulations 2015.

The purpose of this variation is to extend the contract in order to allow sufficient time to implement the recommendations relating to the longer term commissioning arrangements for Aspire services which were approved by the Council's Executive Board in October 2020.

The proposal relates to an extension of existing contractual arrangements, which will not involve a change to the services provided to Aspire service users, and will therefore be highly unlikely to negatively impact any groups of people.

Separate equality screening assessments will be undertaken in relation to the individualisation and respite review work streams to ensure that any unintended negative consequences are identified and addressed.
