Summary

1. Main issues

- This report seeks authorisation to increase the entrance charges at Lotherton from Monday 5th April 2021.
- A comparison with regional attractions show that there is scope to increase charges as Lotherton is £2.71 cheaper than the average for adults and £4.37 cheaper for children in comparison to other regional attractions. The attraction is also unique in allowing children under 5 to enter for free, compared to most other attractions where this applies to children under 3 or younger still.
- Consultation was undertaken by the Museums and Galleries service concerning a proposal to reduce public opening hours at the hall to just weekends and Leeds school holidays. Analysis of the results demonstrated little support for this proposal, with 64% who either disagreed or strongly disagreed. There was however support from 79% of those who responded for an increase in the cost of a day ticket, with 60% favouring a 5% increase.

3. Resource implications

1. Purpose of this report

1.1 This report seeks authorisation to increase the entrance charges at Lotherton from 5th April 2021.

2. Background information

- 2.1 In July 2011 the Council's Executive Board considered a report that set out a programme of investment into Lotherton estate with the aim to become a coherent, quality visitor attraction. Since then the estate has been managed through a joint project board in collaboration with Parks and Countryside along with Museums and Galleries. Under this joint working initiative, income to the whole estate has steadily risen from £575k in 2010/11 to £1.2 million which represents a growth of £630k an increase of 110%. This in turn has had a positive impact on reducing the level of net subsidy associated with the management of the holistic estate.
- 2.2 This growth has been in part driven by a commitment to the promotion and expansion of the onsite event programme (including the Lotherton Christmas Experience), supported by a series of investments into both the visitor focussed elements of the estate and also its infrastructure. Some of the improvements undertaken include the following all of which have helped develop the estate in a sustainable way:
 - The development of an adventure playground and improved children's play
 - Establishment of a new vehicular access route
 - Improved visitor parking
 - Improved signage and interpretation
- 2.3 Penguins were introduced to a new purpose built enclosure in November 2017 ahead of the launch of Lotherton Wildlife World in March 2018. This saw a new visitor centre opened along with the introduction of new species including warty pigs, capybara and tapir. Further improvements planned in future including the following:
 - Africa zone: utilising the existing walk in aviary structure to create a Masai themed centre to include a display/events area with mongoose exhibit
 - Tropical: an existing area will be remodelled to provide an undercover space with new exhibits developed that will include tropical themed species of birds, insects and amphibians.
 - Children's zone: the intention is to create a small children's zoo with some small farm type animals with associated hand wash facilities.
- 2.4 The financial position reported at the Council's September Executive Board identified an estimated budget gap of £163.3m for the period 2021/22- 2023/24. At that time a gap of £118.8m was identified for 2021/22 with the result that a number of budget savings proposals were identified to deliver a balanced budget position. The council budget was approved for 2021/22 at a meeting of all councillors on 24th February 2021.

3. Main issues

- 3.1 A budget saving proposal identified related to reducing opening hours at Lotherton Hall, however following consultation it is now proposed that an increase on admission prices based on 5% is implemented from 5th April 2021.
- 3.2 Prices for entrance into Lotherton were introduced in 2012 and current prices (from January 2020) are as set out below.

- 3.4 These comparisons show that there is scope to increase charges as Lotherton is currently £2.71 cheaper than the average for adults and £4.37 cheaper for children in comparison to other regional attractions. The attraction is also unique in allowing children under 5 to enter for free, compared to most other attractions where this applies to children under 3 or younger still.
- 3.5 There are times during the summer holidays in particular and at weekends and bank holidays when the attraction is extremely busy. Advice from commercial marketing companies is that the best option to raise income in these circumstances is to increase prices.

4. Corporate considerations

4.1 Consultation and engagement

4.1.1 As indicated above, consultation was undertaken by the Museums and Galleries service concerning a proposal to reduce opening hours at Lotherton Hall in the light of the budget situation that the council faced. A survey was made available online over which received 2,836 responses. A summary of the key responses is as follows.

4.1.2 There is little support for a proposal to reduce public opening hours at the hall to just weekends and Leeds school holidays with 64% who either disagreed or strongly disagreed. There was however support from 79% of those who responded for an increase in the cost of a day ticket, with 60% favoured a 5% increase.

5. Conclusions

5.1 The main proposal is to increase charges for adults from £8.30 to £8.75, along with increases for Lotherton Annual Membership and card holders. This will allow the council to ensure that under 5s can still enter free of charge. It also means that 'Extra' cardholders (in receipt of defined benefits) and Breezecard holders would retain a significant discount.
