Summary of Main issues

Approval from the Chief Parks and Countryside Officer is sought to:-

Inject £137,000 from various funding sources for the installation of a new floodlit Multi Use Games Area (MUGA) and link path at Street Lane Recreation Ground in Gildersome. This is shown as:

- £80K Sport England
- £40K Section 106 Greenspace
- £17K Gildersome Action Group

Grant authority to spend £155,659 (this includes £18,659 for the commuted sum which will be held in Parks and Countryside revenue) for the installation of a floodlit MUGA and link path at Street Lane Recreation Ground in Gildersome.

Resource Implications

 Due to capacity issues and estimated scheme costs, Parks & Countryside do not have the resources to deliver this project within budget and the timeframe required. Parks have therefore commissioned NPS to facilitate the scheme which will go out to Tender.

Recommendations

- 1.1 The Chief Officer Parks and Countryside is requested to:
 - Give approval to inject £137,000 from various funding sources for the installation of a new floodlit Multi Use Games Area (MUGA) and link path at Street Lane Recreation Ground in Gildersome. This is shown as:
 - a. £80K Sport England
 - b. £40K S106 Greenspace monies
 - c. £17K Gildersome Action Group Contribution
 - Grant authority to spend £155.659 (this includes £18,659 for a commuted sum which will be held in Parks and Countryside revenue) for the installation of a new floodlit MUGA and link path at Street Lane Recreation Ground in Gildersome.

1. Purpose of this report

1.2 The purpose of this report is to seek approval to inject £137,000 and incur expenditure of £155,659 (this includes £18,659 for the commuted sum which will be held in Parks and Countryside revenue) from a range of funding sources for a new floodlit MUGA and link path.

2. Background information

2.1 Due to a lack of accessible sport and recreational facilities in Gildersome, ward members and the Gildersome Action Group have been working closely with the Parks & Countryside Service to develop a new floodlit MUGA on the playing fields at Street Lane Recreation Ground and planning for the scheme was approved in 2020, though some planning conditions still need to be discharged.

3. Main issues

3.1 Design proposals and full scheme description

The proposal is for a new Floodlit MUGA with adjoining link path, so the facility can easily be accessed by members of the public from the main roadside footpath. The MUGA is designed to meet Sport England requirements in terms of dimensions and layout, of which floodlighting was a requirement in order to access their grant funding.

It is anticipated the Parish Council will liaise with the Gildersome Action Group in terms of programming when the floodlights will come on and go off during the evenings. The lights will be controlled via a timer switch and should be turned off by 9.00PM Monday to Saturday and by 7.00PM on a Sunday.

Programme

The project will be managed by NPS with the scheme delivered by a chosen contractor following a full Tender evaluation. The site works are anticipated to begin no earlier than June 2021.

4. Corporate considerations

4.1 Consultation and engagement

4.1.1 Consultation on the project was carried out with Morley North ward Councillors and the Gildersome Action Group who are in support of the plans.

4.2 Equality and diversity / cohesion and integration

- 4.2.1 A screening document has been prepared and an independent impact assessment is not required for the approvals requested. The screening document has been sent to the equality team to be approved and published.
- 4.2.2 The new facility will be open and accessible to all and will be free to use.

4.3 Council policies and the Best Council Plan

4.3.1 The new floodlit MUGA contributes to the Best Council Plan 2020 - 2025 priorities by supporting health and physical active lifestyles contributing towards the targets to reduce childhood obesity and for a greater percentage of children to participate in regular physical activity.

4.3.2 Climate Emergency

Whilst there will be some removal of the grass surface to be replaced by the MUGA and link path, the design will ensure that adequate drainage is installed to avoid any flooding. The lamps for the floodlights will be low energy LED's and will be controlled by a timer switch. There is a proposal to plant some additional trees in all parks which would support the plan for Leeds to achieve carbon neutral status by 2050. Trees can consume up to 48 pounds of carbon dioxide per year (among other greenhouse gases like ozone), and can release enough oxygen for one person to breath for around two years.

4.4 Resources, procurement and value for money

4.4.1 Full Scheme Estimate – NPS will undertake a full tender process and contractor services procured in line with Corporate Procedure Rules to ensure best value for money. A full tender process and a minimum 3 quotes is a requirement for Sport England to ensure best value when awarding grants.
