Please accept this formal representation by an officer on behalf of Environmental Health Services, Leeds City Council. As a fully qualified Environmental Health Officer I have been seconded into Environmental Health services from the Housing Regulation team to support the councils COVID response. My duties within Environmental Health services include investigating COVID outbreaks and complaints as well as providing support for COVID safety in commercial businesses.

Environmental Health Services has responded to this business on 3 separate occasions since the COVID outbreak was realised in March 2020. Each matter was allocated to a different investigating officer, each one being suitably qualified and authorised by the service.

As the most recent officer to take formal action against this business I have been asked to present the information from these investigations.

All three actions are noted in a timeline that is submitted as additional information. Also included is the content of relevant emails. (Personal information is redacted for data protection).

Copies of the prohibition notices and fixed penalty notices (FPN's) are available as supporting information.

WHEREAS it appears that you are a person who is responsible for carrying on a business at the above premises which is included in Part 1 or Part 2 of Schedule 2 of The Health Protection (Coronavirus, Restrictions) (England) Regulations 2020 ("the Regulations").

TAKE NOTICE that, pursuant to the powers conferred by the Regulations you were required from 1 p.m. on 26th March 2020 and until the emergency period is ended by the Secretary of State to comply with the Regulations

AND this Notice requires that you comply with the following:

1. Close premises and businesses (Regulation 4)

- (iii) Not admit any person to the premises who is not required to carry on that business or provide that service as permitted by 2(i) above.

On the 24th January 2021, Bobs Bar and Restaurant carried on a business/provided the service of shisha listed in paragraph 15(2) other than as permitted by the exceptions listed in paragraph 12, and being in contravention of regulation 8, and Part 3 of Schedule 3A, paragraph 10(1), to The Health Protection (Coronavirus, Restrictions) (All Tiers) (England) Regulations 2020

In relation to a breach of a Tier 4 restriction imposed by regulation 8 and Part 3 of Schedule 3A, paragraph 11(1) (Restrictions on service of food and drink for consumption on the premises - applies to business or service listed in paragraph 15(6), or is carried on from, or provided at, premises of a kind specified in paragraph 15(6)):

On the 24th January 2021, Bobs Bar and Restaurant carried on a business/provided a service other than as permitted by the exceptions listed in paragraphs 12 and 13 namely: provision for consumption of alcoholic drinks and being in contravention of regulation 8, and Part 3 of Schedule 3A, paragraph 11(1), to The Health Protection (Coronavirus, Restrictions) (All Tiers) (England) Regulations 2020

Particulars of the offence: On the 24th January 2021, at approximately 00.30hrs the police were dispatched to a complaint of COVID restrictions being breached at Bobs Bar and Restaurant. Officers entered these premises where several persons were observed with shisha and alcoholic beverages.

Part C. Action required

This Prohibition Notice requires that you immediately cease the activities identified in Part B giving rise to contravention of the Regulations. The measures specified below must be taken to prevent continued contravention of the Regulations:

- 1. Cease providing shisha for people to smoke on the premises at Bobs Bar and Restaurant, 3 Sheepscar Street South, Sheepscar, Leeds, LS7 1AD
- 2. Cease providing alcoholic drinks, food and drink for people to consume on the premises at Bobs Bar and Restaurant, 3 Sheepscar Street South, Sheepscar, Leeds, LS7 1AD

Part D. Consequences of non-compliance with this Notice, and with the Regulations

Failure to comply with this Prohibition Notice, without reasonable excuse, is an offence under regulation 10 of the Regulations, punishable by a fine on summary conviction in a Magistrates' Court.

A fixed penalty notice may be issued in accordance with regulation 11 and 12 of the Regulations, or you may be prosecuted under regulations 10 and 13 of the Regulations.

NOTES on Part B. Amount of Penalty and period to pay

In the case of a fixed penalty notice issued in respect of a business restriction offence, the amount of the fixed penalty to be specified under regulation 11(5)(c) is—

- a. £1,000, if the fixed penalty notice is the first one issued to the person in respect of a business restriction offence
- b. £2,000, if the fixed penalty notice is the second one issued to the person in respect of a business restriction offence
- c. £4,000, if the fixed penalty notice is the third one issued to the person in respect of a business restriction offence
- d. £10,000, if the fixed penalty notice is the fourth one, or any subsequent one, issued to the person in respect of a business restriction offence.

Note: Unless otherwise specified, a "business restriction offence" means—

- a. an offence under regulation 10(1)(a) of contravening

Timeline of events relevant to Environmental Health's history of investigations and enforcement.

26.03.2020. Formal lockdown starts. Hospitality closed.

15.06.2020 – email from the police to the licensing team LCC and forwarded onto Environmental health for action.

In summary of the email;

- Officers were called to "BOBS BAR" SHEEPSCAR STREET following a report that there was a party and regular drinking during the pandemic.
- On arrival at approx. 2am there was loud music and the bar area had 6 persons in the main bar area, with searches revealing 10 hiding in the cellar, and a further 2 persons hiding in the gents toilet.
- The owner was cooperative but prior to the other persons (found hiding he had indicated that there was no one in the premises, he had a side door open which made officers initially be led to believe that persons were on premises but had made their way out).
- ASFAHA was attempting to mislead officers.
- ASFAHA was advised and the coronavirus legislation was reiterated.
- Request made for further appropriate action be considered as part of the licensing conditions in the current circumstances.

The matter was allocated to Mr. Karl Sheldon who consequently served prohibition notices.

04.07.2020 – Restrictions eased on hospitality. Pubs and restaurants allowed to re-open until 10pm.

02.10.2020 – Anonymous complaint received by licensing Officer – Martyn Musson. Referred to Environmental Health for further action.

Complaint information is summarised below;

- Anonymous complaint from a customer in regards to Bobs Bar and Restaurant.
- Queue management The Customer didn't need to queue or book and walked in and sat at a table with his children
- Track and test The customer did not sign in or fill out any T&T details on any format and wasn't told to.
- Sanitiser The Customer did sanitise on entry.
- Space between tables The customer did not believe there was enough space between tables while they sat to eat.
- Smoking areas The Customer said that several groups of 5/6 people were smoking Sheesh inside the premises while customers were eating.
- Single use condiments The customer mentioned the table was busy with condiments.
- Face coverings Although the customer was wearing a face covering, he said that all the staff and customers walking around and smoking was not wearing appropriate face coverings.
- The main complaint was about his children inhaling second-hand smoking from the sheesh that was being smoked indoors.

05.10.2020 – Allocated to Mr. Jamie Freil – Senior Environmental Health Officer.

06.10.2020 – Mr. Friel responded with an advisory email – no further action was taken and the matter was closed. Email unavailable at the time of preparing this information.

05.11.2020 – 2nd National Lockdown comes into force.

02.12.2020 - 2nd National lockdown ends. Tier Regs come into effect. Leeds in Tier 3. Hospitality remains restricted.

06.01.2021 – 3rd National Lockdown starts. Hospitality restricted.

24.01.2021 – Breach of lockdown witnessed by police – email from investigating officer forwarded. Is summarised below;

Subject: Bobs Bar, 3 SHEEPSCAR STREET SOUTH

- We have attended log 0037 today at 3 SHEEPSCAR STREET SOUTH, which is Bobs bar. Upon arrival we have seen someone move from the main premises into a little hut to the side of it and deliberately locked police out.
- After a period of time of banging, knocking, and shouting they would not allow us entry. I
 have had to climb the fence and eventually they have opened the door after blocking the
 door and us having to force people in.
- Gaining entry there was 8 people present, including a male called Beniam ASFAHA,
 10/06/1983, 49LINDSEY MOUNT who stated he was the licence holder.
- Inside the little outbuilding they were drinking alcohol and smoking Shisha. It is very apparent the owner is using the restaurant / bar during covid and has no regard for legislation.
- All males and females issued COVID-19 Warnings except one, who had already had a warning and was reported for a fine due to the breach.

25.01.2021 – allocated to Mr. Steve Clarke (Environmental Health Officer EHS).

28.01.2021 – Witness statements received from the investigating officers provided sufficient evidence to justify serving a prohibition order under the current legislation.

Fixed penalty notices are served on the premises licence holder Mr. Biniam Kesete Asfaha and the DPO Mr Mehari Andemariam. Both posted 1st class and deemed to be legally served 30th January 2021.

These attached notices are copies of those legally served today following a police visit on Sunday 24th January where a breach of COVID restrictions was evidenced.

The prohibition notice is a legal requirement with immediate effect. The premises must not be open again until further notice.

The fixed penalty notice is a fine for failing to comply with the law that requires your closure to reduce COVID infection rates.

Please read the notices carefully. You are advised to seek legal assistance should you fail to understand them. If you continue to operate and ignore COVID restrictions we will escalate enforcement as appropriate.

01.02.2021 – Investigating officer received a phone call from Biniam Kesete Asfaha. 'Mr. Asfaha explained to me that he had been in the process of closing his premises and that the gathering was his employees who were helping him shut down and move furniture. They'd all stayed behind as a social event that he'd put on as a thank you for their help. I explained the evidence received, the notices and FPN's. He was upset that he couldn't afford the fine. He accepted full responsibility for the event and didn't want his supervisor involved. He said the fine would be paid, and he didn't want this held against him because he wants to open another business again sometime.'

A following call was received shortly after from Mehari Andemariam in which Mr. Andemariam denied any knowledge of this event.

01.04.2021 - To date. No further information has been received to indicate that the prohibition notices have been breached.
