Summary

1. Main issues

- The Department for Work and Pensions has announced an extension to the COVID Grants Support until 20th June 2021. Funding has been allocated to local authorities across England. The COVID Local Support Grant has the same eligibility criteria, and uses the same reporting template as the previous COVID Winter Grant Scheme. Leeds City Council has been allocated £667,660 to use from 17th April until 20th June.
- The initial COVID Winter Grants Scheme was first announced in November 2020 with Leeds City Council receiving £2,837,556.77 to be spent between December 2020 and 31st March 2021. In February 2021 the DWP announced an extension to the scheme until 16th April 2021. Leeds City Council was allocated £986,468.
- The majority (£1.7m) of COVID Winter Grants funding was approved to be allocated to for the provision of free school meals to children living in poverty in the city for the Christmas 2020, February 2021 and Easter school holidays. This included schools being able to access support for an additional 10% more children who aren't eligible for FSM but are in need of assistance. In total approximately 33,000 children and young people have been supported each holiday period.
- A key decision was taken in March 2021 to accept the £986,468 COVID Winter Grant Extension funding from the Department for Work and Pensions for 2021, to provide children eligible for free school meals with food support over the Easter holidays. In addition it was agreed to accept any further future funding allocated

from Government for the provision of free school meals for school holiday periods for children eligible for free school meals and/ or living in poverty.

- The COVID Local Support Grant of £667,660 would enable the Council to provide schools with the support for the provision of free school meals for the Easter school holidays. The remaining funding would be used to support vulnerable families and individuals with the costs of food, fuel and essential items.

2. Best Council Plan implications (see the [latest version of the Best Council Plan](#))

- The Department for Work and Pensions COVID Local Support Grant contributes to the Best Council Plan focus of tackling poverty and reducing inequalities, and achieving the council's ambition for a strong economy and compassionate city. The funding supports the Best City Priorities of Child Friendly City, Safe, Strong Communities, Inclusive Growth, and Health & Wellbeing.

3. Resource implications

- Leeds City Council has been allocated an additional £667,660 from the Department for Work and Pensions COVID Local Support Grant. The funding is to enable Local Authorities to provide support to families with children, other vulnerable households and individuals until 20th June, with the cost of food, energy (heating, cooking and lighting), water bills (including sewerage) and other essentials.

Recommendations

The Director of Children and Families is requested to;

- a) Accept the £667,660 COVID Local Support Grant funding from the Department for Work and Pensions.
- b) Agree for the COVID Local Support Grant funding to be principally used to provide meals for children eligible for free school meals and children living in low income households over May 2021 half term. For the remaining funding to be used to support vulnerable families and individuals with the costs of food, fuel and essential items.

1. Purpose of this report

- 1.1 The purpose of this report is to accept an additional £667,660 of COVID Winter Grants Scheme funding from the Department for Work and Pensions.
- 1.2 To agree to provide children eligible for free school meals and children living in low income households with free school meals over the May 2021 half term.

2. Background information

- 2.1 On the 8th November, 2020, the government announced a £170 million COVID Winter Grant Scheme (CWGS). This funding enables local authorities to provide support to families with children, other vulnerable households and individuals from early December 2020 and covers the period until the end of March 2021.

- 2.2 The CWGS funding is to enable local authorities to support those most in need with the cost of food, energy (heating, cooking and lighting), water bills (including sewerage) and other essentials.
- 2.3 Leeds was initially allocated £2,837,556.77. The funding was ring-fenced and time limited (01/12/2020 – 31/03/2021), with any funds not spent, sent back to Government. An extension to the scheme in February 2021 awarded the Council an additional £986,468 to be used until 16th April.
- 2.4 The national guidance stipulated that:
- At least 80% must be allocated to households with children, the remainder to individuals or households without children.
 - Of those allocations, 80% must be in relation to food, fuel, water and other household bills (not rent/housing costs), with the remainder on other essentials clearly linked to the scheme's conditions.
 - Local Authorities can provide funding to partners to support the delivery of the scheme. Food banks, charities and schools are among those who are classified as partners.
 - Local Authorities must provide management information to demonstrate the number and value of allocations for all cases where the payments are made to individuals as Cash, Voucher or Bank Transfer. Each must be counted separately and classified against each spend centre (Food, Fuel, Water OR other)
 - Local Authorities can attribute reasonable administration costs to this fund but are asked to keep it to a minimum. All expenditure (including costs allocated to administration) will be published on GOV.UK
- 2.5 The majority (£1.7m) of COVID Winter Grants funding was approved to be allocated to for the provision of free school meals to children living in poverty in the city for the Christmas 2020, February 2021 and Easter school holidays. This included schools being able to access support for an additional 10% more children who aren't eligible for FSM but are in need of assistance. In total approximately 33,000 children and young people have been supported each holiday period.
- 2.6 The remain funding has been used to provide;
- Food, fuel and essential items directly to low income families with children under the age of 4 and care leavers.
 - Assistance towards the cost of fuel to families and individuals claiming Council Tax Support.
 - Support to third sector organisations and charities who support vulnerable families and individuals for food and essential items.

3. Main issues

- In April 2021 the Department for Work and Pensions announced an extension to the COVID Grants Support until 20th June 2021. Funding has been allocated to local authorities across England. The COVID Local Support Grant has the same eligibility criteria, and uses the same reporting template as the previous COVID Winter Grant Scheme. Leeds City Council has been allocated £667,660 to use from 17th April until 20th June.

- 3.1 It is proposed that the majority of this additional funding received by Leeds City Council is allocated to work with schools in the city to continue the provision of free school meals to the approximately 33,000 children living in poverty in the city for May 2021 school holiday. This would involve replicating the approach undertaken over February and Easter 2021 school holidays.
- 3.2 For February and Easter school holidays, schools using Catering Leeds as their meal provider were asked if they wanted to opt in to a hamper scheme for the week or receive funding per pupil to provide a scheme (hamper or voucher) of their own. All other schools were funded directly to administer their own scheme. The funding received was based on the number of children on Free School Meal, in families who have no recourse to public funds or are on a low income. Approximately 33,000 children and young people were supported.
- 3.3 Schools are familiar with the system and processes in place to support families. Adopting this approach for Easter School holidays will ensure that children and young people in families most in need receive support.
- 3.4 In terms of decision making, a key decision was taken in March 2021 to accept the £986,468 COVID Winter Grant Extension funding from the Department for Work and Pensions for 2021, to provide children eligible for free school meals with food support over the Easter holidays. In addition it was agreed to accept any further future funding allocated from Government for the provision of free school meals for school holiday periods for children eligible for free school meals and/ or living in poverty.

4. Corporate considerations

4.1 Consultation and engagement

- 4.1.1 All relevant Executive Members have been briefed on the guidance and remit of the funding and the proposed approach for May 2021.
- 4.1.2 Schools, Catering Leeds and relevant Chief Officers have also been consulted on this approach.

4.2 Equality and diversity / cohesion and integration

- 4.2.1 The focus of the COVID Local Support Grant is to support vulnerable families and individual suffering hardship, poverty and inequality, and therefore issues of equality, diversity, cohesion and integration are key aspects of this work.
- 4.2.2 In addition to the whole Free School Meal cohort being supported, schools are able to access support for children and young people who they feel would also benefit.

4.3 Council policies and the Best Council Plan

- 4.3.1 The Department for Work and Pensions COVID Local Support Grant contributes to the Best Council Plan focus of tackling poverty and reducing inequalities, and achieving the council's ambition for a strong economy and compassionate city. The funding supports the Best City Priorities of Child Friendly City, Safe, Strong Communities, Inclusive Growth, and Health & Wellbeing.

Climate Emergency

4.3.2 As the climate continues to change, extreme weather patterns across the globe will become increasingly common. The knock on effects of these changes will be profound, however it is hard to determine what specifically they will look like. What is certain is that there will be scarcity of various resources, such as food and energy, which could lead to a price increase, which will have a disproportionate impact on people who live in poverty. We should seek to mitigate the impact of poverty and reduce insecurity and inequality around these basic needs to build strengthened communities for the future.

4.4 Resources, procurement and value for money

4.4.1 Leeds City Council has been allocated an additional £667,660 from the Department for Work and Pensions COVID Local Support Grant. The funding is to enable Local Authorities to provide support to families with children, other vulnerable households and individuals until 20th June, with the cost of food, energy (heating, cooking and lighting), water bills (including sewerage) and other essentials.

4.4.2 The additional funding will be dispersed by July 2021 using the same formula as the original grant. Local Authorities will receive their additional allocation in July 2021 on the completion of the final management information (MI) report in July 2021.

4.5 Legal implications, access to information, and call-in

4.5.1 A key decision was taken in March 2021 to accept the £986,468 COVID Winter Grant Extension funding from the Department for Work and Pensions for 2021, to provide children eligible for free school meals with food support over the Easter holidays. In addition it was agreed to accept any further future funding allocated from Government for the provision of free school meals for school holiday periods for children eligible for free school meals and/ or living in poverty. The COVID Local Support Grant adheres to the same guidance and criteria of the COVID Winter Grants Scheme, and therefore is linked to the key decision taken in March.

4.6 Risk management

4.6.1 Leeds City Council will ensure that the provision of support undertaken meets the objectives and criteria set out by the DWP for the COVID Local Support Grant funding.

5. Conclusions

5.1 The expansion of the COVID Local Support Grant to 20th June by the Department for Work and Pensions, will ensure that children eligible for Free School Meals, in families who have no recourse to public funds or are on a low income across the city to receive free school meals over the May school holidays.

5.2 Having undertaken this exercise for Christmas, February and Easter school holidays, there is an established and trusted process in place between Leeds City Council and schools in the city.

5.3 Any remaining funding will be used in adherence to the DWP guidance to support vulnerable families and individuals with food, fuel and essential items.

6. Recommendations

6.1 The Director of Children and Families is requested to;

- a) Accept the £667,660 COVID Local Support Grant funding from the Department for Work and Pensions.
- b) Agree for the COVID Local Support Grant funding to be principally used to provide meals for children eligible for free school meals and children living in low income households over May 2021 half term. For the remaining funding to be used to support vulnerable families and individuals with the costs of food, fuel and essential items.
