details ³ :	 (Set out all necessary decisions to be taken by the decision taker including decisions in relation to exempt information, exemption from call in etc.) The Chief Offiicer, Culture and Economy has approved Covid-19 business support payments to catteries and kennels as follows: A one-off payment will be made to each cattery and kennel based in Leeds in lieu of a Covid-19 Restart Grant. This is in addition to any grants made in lieu of Local Restrictions Support Grant (Closed) payments as set out in Decision ref: D52793. Payments will be calculated based on the Restart Grant payments made to non-essential retail businesses on the basis that as overnight stays were permitted from Step 2 on 12 April 2021 catteries and kennels would have seen an uptick in business from this point. This was the date when non-essential retail re-opened. Businesses with a rateable value less than £15,000 (all but one of the catteries and kennels in Leeds) will receive £2667. Businesses with a rateable value above £15,000 will receive £4000.

The financial commitment will be no more than £73,342.
A brief statement of the reasons for the decision

The government's Restart Grant was put in place to support businesses re-
opening after the coronavirus lockdown. Whilst catteries and kennels were in
effect closed due to coronavirus restrictions they were not required to close
under the law and have been explicitly excluded by government from the
Restart Grant. However, this does not exclude the council from using its
discretion to award an equivalent grant amount using the Covid-19 Additional
Restrictions Grant (ARG) allocation.
Leeds City Council previously decided to support catteries and kennels with the
equivalent Local Restrictions Support Grant (Closed) payments making use of
discretionary funds to do so (refer to D52793). Having taken this decision it
would therefore be inconsistent not to support catteries and kennels with a
Restart Grant funded through the ARG allocation.

Providing this support will not have a detrimental impact on our ability to support other businesses through our Discretionary Grant Schemes.

Consideration was given as to whether catteries and kennels should be supported through our Discretionary Grant Scheme. However, having prevsiously supported caterries and kennels through equivalent LRSG (Closed) payments (refer to D52793) it would be inconsistent not to support catteries and kennels with an equiavlent Restart Grant funded through the ARG allocation.
