Thank you for taking the time out to discuss our position. It was helpful to understand what we can do now and, in the future, to support greater licensing flexibility.

To surmise our conversation, we agreed that on Saturdays only, the club will be allowed to operate till 24.30 with drinking up time stipulated at 24.00hrs, but all entertainment provision

i.e. recorded and or live music or similar, must be at lowered to background level, after 11pm.
The other days of the week, the club must adhere to a 23.00hr finish of licensable activities.

We consider this a reasonable adjustment and would like to thank you for your kind consideration.

I have reviewed the licensed premises application you recently submitted for the above premises. Generally I am not against the application but there are a couple of issues which would lead me to object to the application:-

1. Operating hours/live music/recorded music until midnight Sunday to Thursday and 2 am Friday/Saturday – given the previous noise issues with the premises, the nature of the building, and the proximity to residential properties, I would suggest existing hours are retained i.e. 11pm Monday to Sunday.

2. Live/recorded music outdoors – due to the proximity to residential properties I don't see how you would manage to prevent music being audible at the nearest noise sensitive premises as described in your application. I would prefer the music to be limited to indoors only.

If you are insistent on keeping the applied hours, and outdoor activities, then I would need to submit a qualified objection and the licensing panel would decide. If you are in agreement, I can let Entertainment Licensing know.
