What is this report about?

Including how it contributes to the city's and council's ambitions

- To approve appointments to Committees, Boards and Panels in consultation with relevant Group Whips during the period between the Annual Council Meeting (20 May 2021) and the first ordinary meeting of Council (14th July 2021), in order to ensure that meetings held during that period can proceed with adequate and appropriate membership levels.
- Specifically, in consultation with the Group Whip, it is proposed that Councillor Heselwood be replaced by Councillor Jenkins on South and West Plans Panel.

Recommendations

a) That following consultation with the Group Whip, the Head of Democratic Services approve the appointment of Councillor Jenkins to South and West Plans Panel as a replacement for Councillor Heselwood, which will be reported to the first ordinary meeting of Council.

Why is the proposal being put forward?

1 The proposed appointment is being put forward by the Chief Whip in order to ensure that meetings held during the period between the Annual Council Meeting and the first ordinary meeting of Council can proceed with adequate and appropriate membership levels.

7 In not making the appointment there is a risk that the South & West Plans Panel meetings held during the period between the Annual Council meeting and the first ordinary meeting of Council may not have full membership levels. This risk is being managed by the proposed appointment.
