The Leeds Suicide Bereavement Service is a support and postvention service for people bereaved by suicide. The service is provided by Leeds Mind, and the contract started in June 2018.

The service provides a range of support including one to one introduction and counselling sessions, regular peer support drop in groups, 'living with grief and loss' courses and specialist family support.

The service is linked to Police, Ambulance, Coroner's Office primary care and bereavement charities who make referrals into the service and highlight any potential clusters of deaths by suicide whereby one fatality can be followed by others known to the deceased.
