Directors of Adult Social Care have a statutory responsibility to ensure and adequate and quality market for support in their area, and this system will enable a consistent approach to this duty.

No direct consultation with the protected groups has been undertaken on this procurement, but each Local Authority has arrangements for engagement with both care providers and people with lived experience and use these to underpin theor commissioning and contracting arrangements.
