## What is this report about?

### Including how it contributes to the city's and council's ambitions

- The Leeds City Council Fostering Service is registered with OfSTED and regulated under the National Care Standards Act 2000 and Fostering Regulation, 2011, and National Minimum Standard for Fostering.
- This report provides an overview of the work of the Fostering Service during the 2020/21 financial year.
- Leeds City Council is committed to all children who are looked after living in a family context where ever possible. Where a child's family are unable to offer care for a child, a child maybe placed with a foster family. The Fostering Service is responsible for ensuring that foster families are recruited, supported and enabled to care for children in the care of Leeds City Council.
