

The drafting of a neighbourhood plan is desirable for both the Chapel Allerton area and the Council, and the neighbourhood forum designation is a critical requirement of the neighbourhood planning process and allows the group to continue public engagement and start drafting the issues and opportunities and potential policies for the neighbourhood plan.</p>
