The Wellbeing Space and Support service is Public Mental Health and wellbeing service that engages people with low level mental health problems, or those at risk of low-level problems, in the community through a range of activities and groups. Your Space uniquely provides a service on an out of office-hours basis - groups are predominately delivered during an evening and at weekends.

The contract is delivered by Touchstone as the lead partner, in conjunction with Holbeck Together and Women’s Health Matters. The current contract began 1st April 2019 and will cease 31st March 2022. A decision is being sought to use the 12-month extension clause.

This will provide continuity of provision for those communities experiencing high prevalence of poor mental health outcomes.

This will also bring the commissioning cycling period in line with Mentally healthy Leeds commissioning cycle. Allowing for a review of preventative public mental health provision in the future.
