#### What is this report about?

## Including how it contributes to the city's and council's ambitions

 To approve appointments to Outside Body organisations following a consultative meeting of the Inner North West Community Committee, in order to ensure that appropriate Council representation upon those Outside Bodies which the Committee has authority to make appointments to is in place ahead of the next scheduled Community Committee meeting.

#### Recommendations

a) That following the consultative meeting of the Inner North West Community Committee on 15<sup>th</sup> July 2021, the Head of Democratic Services approve those appointments as detailed within paragraph 1, in order to ensure that appropriate Council representation upon those Outside Bodies which the Committee has authority to make appointments to is in place ahead of the next scheduled Community Committee meeting.

#### Why is the proposal being put forward?

The Inner North West Community Committee held a remote, consultative meeting on 15<sup>th</sup> July 2021. Although that meeting could not make formal decisions, it did make a number of recommendations for appointments to those Outside Bodies which the Committee has authority to make appointments to. The proposed appointments are being put forward, in order to ensure that appropriate Council representation upon those Outside Bodies is in place ahead of the next scheduled Community Committee meeting:

- 6 The City Solicitor has sub-delegated this responsibility to the Head of Democratic Services and the Deputy Head of Democratic Services.

7 In not making the appointments there is a risk of there not being appropriate Council representation upon those Outside Bodies which the Committee has authority to make appointments to ahead of the next scheduled Community Committee meeting.
