The decision to award a contract, which will go out to competitive tender for the delivery of an “Inclusion Support Service” from 1st April 2022 for two years at a value of £257,000 per annum. There will be the option to extend for two further twelve month periods to 31st March 2026.

The “Inclusion Support Service” will work to increase the number of children and young people (CY&P) with special educational needs and/or disabilities (SEND) accessing mainstream fun activities.
