What is this report about?

Including how it contributes to the city's and council's ambitions

The Leeds Community Equipment Service operates under a Better Care Fund Agreement between Leeds City Council and Leeds Clinical Commissioning Group (CCG). Leeds City Council is the lead commissioner for the arrangement and Adults and Health are the lead provider in the Partnership and deliver the Service in partnership with Leeds Community Healthcare.

On 12th April 2017, approval was given via delegated decision by the Director of Adults and Health for permission to establish a four-year framework arrangement for the supply of community equipment for Disabled People for Adults & Health and Children's Services.

On 17th March 2021 approval was given by the Director of Adults and Health to use Regulation 72 (1) (c) of the Public Contract Regulations 2015 to vary the end date of the framework agreement for the supply of Assistive Technology Equipment for Daily Living (contract reference DN199814) for all suppliers listed under the framework for a further 12 months (from 1st June 2021 to 31st May 2022).

Approval is now sought to undertake a procurement exercise, in order to establish new contracts with effect from 1st June 2022, in order to maintain continuous provision of these services.

The anticipated value of the 4-year Framework contract will be £10,764,400.00 based on 2021/22 base budget.

Recommendations

The Director of Adults and Health is requested to -

- Approve the undertaking of a procurement exercise to procure a four-year framework agreement
- Approve the proposed timescale for implementation from 1st June 2022.

• Note that the Service Delivery Manager- Assisted Living Leeds will be the officer responsible for the implementation.

Why is the proposal being put forward?

The purpose of this report is to seek approval via delegated decision by the Director of Adults and Health to approve the undertaking of a procurement exercise to procure a four-year framework agreement, for the supply of Community Equipment.

The approval is being sought in order to establish new contracts with effect from 1st June 2022, to maintain continuous provision of these services.

This procurement strategy as outlined in this report provides the flexibility and innovation required by the service to ensure customers' needs are met by the most up to date product.

What impact will this proposal have?

- The Leeds Community Equipment service provides a range of community equipment to disabled adults, older people and children within Leeds and other partner authorities
- There will be no adverse effect on any particular groups of people within the city by the proposal.

What consultation and engagement has taken place?

- The procurement process to establish the framework agreement will include officers from Adults & Health, Children's Services and Leeds Community Healthcare. Officers involved in the procurement process are from both provider and assessment services. The same officers are involved in the development of the product specifications. Service users from the user involvement group will be part of the evaluation process.
- Ongoing consultation will take place involving officers from Leeds Community Equipment Services, Commissioning officers, Children's Services and the market.
- The process has been overseen by Procurement and Commercial Services.

What are the resource implications?

- A full open competitive procurement process will be undertaken in order to ensure that the Council obtains best value for money, in terms of fit for purpose products at the best price.
- The framework agreement will ensure items of equipment are purchased at best value rates. The service will be able to purchase equipment in a timelier manner and plan the year's expenditure. Officer time will be saved by working to the framework which historically has produced competitive rates rather than obtaining quotes (that contravenes Contracts Procedure Rules through disaggregation) for individual items and orders.
- Pooled budget funding for Community Equipment has been approved.
 The framework agreement is for the supply of community equipment for daily living to Leeds Community Equipment Service with an annual base budget of £1,842,000 per year for adult

social care and health equipment, £400,000.00 for CHC Adults and £449,100 per year for children's equipment (which is made up of £220,100.00 from LCC contributions and £229,000.00 CCG's contribution). This provides a total base budget of £2,691,100. Based on 2021/22 budget allocation.

- The total budget available for the four-year contract is £10,764,400.00 based on 2021/22 base budget.
- A competitive procurement exercise will be undertaken in compliance with the Public Contracts Regulations 2015 which will be advertised on the Find a Tender service in order to ensure that the Council complies with the regulations on advertising tendering opportunities with the proviso of obtaining best value for money, in terms of fit for purpose products at the best price.
- Suppliers are appointed ranked by order of price on a line by line basis. The lowest priced
 item will be ranked in first place, the next lowest priced item will be ranked in second place
 and so on. All customers will procure goods from Lot 1 and Lot 2 as a direct call-off without
 competition and will endeavour to obtain value for money by procuring the cheapest goods
 available from the ranked list of framework goods.
- Lot 3 is for Special Equipment & Bespoke Items.
 This Lot is for suppliers offering products other than those awarded items specified within Lot 1 or Lot 2. Suppliers will be asked if they are able to supply and provide quotations and any discounts. This may include a hire rate as well as a purchase price to enable quicker access to equipment in the short term for hospital discharge.

What are the legal implications?

- This is a Key Decision and is subject to call-in and was published on the List of Forthcoming Key Decisions on 18th January 2021. The report does not contain any exempt or confidential information under the Access to Information Rules.
- Subsequent decisions arising from this report, for example the decision to award the contract, will be treated as a consequence of this Key Decision and will therefore be treated as a significant operational decision at most, which will not be subject to call in.
- Procurement and Commercial Services (PACS) will advertise the tender via the Find a
 Tender service in compliance with the Public Contracts Regulations (2015). The framework
 will also be advertised on the Council's tendering website YORtender and Contracts Finder.
- Advice has been sought from Procurement and Commercial Services throughout the duration
 of the review and procurement process and will continue to be sought through to contract
 award.

What are the key risks and how are they being managed?

The current contract is due to end on 31st May 2022 with no option to extend available. Not to have a contract in place will lead to significant non-contract spend and therefore, a new contract is required to meet the existing demand for the products for the service.

It is proposed that a four-year framework is established.

This framework will consist of three Lots:

- Lot 1 Supply of equipment for Daily Living for Adults
- Lot 2 Supply of equipment for Daily Living for Children
- Lot 3 Special equipment and Bespoke items including the short-term hire of equipment.

The annual cost of the contract is £2,691,100.00

The anticipated value of the four years framework contract will be £10,764,400.00 based on 2021/22 base budget.

The Leeds Community Equipment Service operates under a Better Care Fund Agreement between Leeds City Council and Leeds CCG. Leeds City Council are the lead commissioner and Adults and Health are the lead provider in the Partnership and deliver the Service in partnership with Leeds Community Healthcare.

The service provides a range of equipment to meet daily living and nursing needs for disabled adults, older people, and children. Equipment purchased by the Council, including that purchased through the Pooled Fund, is subject to procurement through Leeds City Council's procurement arrangements.

The service contributes to National Indicator 142: the percentage of vulnerable people supported to achieve independent living.

Best Council Plan 2020 – 25 – this work contributes to the Better Lives programme and to the breakthrough project of making Leeds the best city in which to grow old. This work contributes making the Health and Wellbeing Leeds KPI by proportion of people who use social care services who have control over their daily life

An Equality Impact Assessment screening tool (Appendix 1) was been undertaken for the tender agreement and has indicated that an EIA does not need to be carried out. There will be no adverse effect on any particular groups of people within the city by the proposal.

The Leeds Climate Commission have proposed a series of science-based carbon reduction targets for the city so that Leeds can play its part in keeping the increase in global average surface temperatures to no more than 1.5°C.

Environment and Sustainability considerations will be taken into account while developing the framework. Provisions will be included which advise that the service will work with suppliers to ensure that they assist Leeds City Council to achieve their carbon reduction targets and reducing emissions across its fleet and operations.

In terms of specifics for this contract, the provision of community equipment is a preventative measure that may reduce or eliminate the need for additional transport for the customer to hospital and also may reduce the package of care to the customer therefore reducing the number for visits from homecare staff. Both impacts are carbon positive in as much as they are removing the need for unnecessary journeys.

Providers will be required to provide Social Value proposals in respect of Climate Change and the Environment. Social Value proposals provided by tenderers are a non - scoring element of the Tender evaluation. However, the commitment proposed by appointed providers will be monitored throughout the contract duration as part of the contract management process

Options, timescales and measuring success

a) What other options were considered?

- The current framework ends on the 31st May 2022 with no option to extend. Not to have a
 contract in place will lead to significant non-contract spend and therefore, a new contract is
 required to meet the existing demand for the products for the service.
- Should no contract be formalised the higher unit costs on the budget would have a direct impact on customer waiting times for equipment. The ability of the Council, to provide the right equipment quickly to enable people to live independent and inclusive lives, would be compromised.

b) How will success be measured?

- Contract is awarded within the timescale.
- The contract will include scheduled contract management meetings between the providers and LCC officers to discuss operational issues, product quality and deliver problems, if they occur over the duration of the contract.

c) What is the timetable for implementation?

The timescale for implementation is 1st June 2022.
