What is this report about?

Including how it contributes to the city's and council's ambitions

- The Townley commode (similar to a sideboard) is a unique and significant piece of furniture dating from c. 1770 made in tulipwood, sycamore, amaranth and satinwood with a lava and specimen marble top.
- It has been agreed for acquisition for the collection at Temple Newsam by the Leeds Museums & Galleries' Collections Development committee in line with the service's collections management policies and procedures.
- Leeds Museums & Galleries contribute significantly to the Best Council Plan, not least through the service's delivery of culture. New acquisitions to the collections provide opportunities for new displays, interpretation and engagement. This acquisition will add to the Designated decorative art collections, ensuring they continue to be of national and international significance.
- The cost of the acquisition will be fully funded by a grant from the Leeds Art Fund, therefore making best use of resources in line with the Best Council Plan.
- The acquisition cost is £196,500. In accordance with the LCC Contracts Procedure Rule 9.5 where there is genuinely no competition, the lack of competition must be formally evidenced and approved by the relevant Chief Officer.

Recommendations

- a) The Chief Officer, Culture & Economy, approves the procurement of the acquisition in line with CPR 9.5.
- b) The grant is claimed from the Leeds Art Fund by the Head of Collections & Programmes.
- c) The purchase order is raised accordingly by the Head of Collections & Programmes.

Why is the proposal being put forward?

- 1 Leeds Museums & Galleries continue to make acquisitions to the collections in line with the Collections Development policy and the acquisition of the Townley Commode adds a unique piece of 18th Century furniture to the decorative art collection. It is a unique piece and therefore meets the criteria set out in 9.5 of the Contracts Procedure Rules. Given that the acquisition is fully grant funded, it is therefore recommended that the Chief Officer, Culture & Economy, approves the procurement of the acquisition.
- 2 The function of this report is to formally evidence the lack of competition in this procurement and therefore in line with CPR 9.5 for the Chief Officer to approve.
