details ³ :	relation to exempt information, exemption from call in etc.) The Chief Officer, Culture & Economy has approved the acceptance of a grant of £249,810 from the National Lottery Heritage Fund (NLHF) to support the restoration of the Decorative Scheme in Victoria Hall.			
	A brief statement of the reasons for the decision (Include any significant financial, procurement, legal or equalities implications, having consulted with Finance, PACS, Legal, HR and Equality colleagues as appropriate) The NLHF grant is significant and given the current financial situation the council finds itself in, the funding will cover extensive resoration costs. The remaining expenditure will be covered by ring-fenced finance as part of the Town Hall refurbishment project. The project will not add any new financial pressure on the council. Colleagues in Legal and Procurement have been consulted. Advice regarding NLHFs T&C's have been acted upon. A window of opportunity to implement the works (when the building will be closed to the public) will allow the project to proceed unhindered.

	A small scale intervention to temporarily mask the decline of the decorative features in Victoria Hall has been considered. However this approach would cost the council more money in the long run and the opportunity to carry out extensive and far reaching restoration works when the building is closed will have been missed. Small scale intervention will also conflict with the council's approach to the climate emergency as interventions will be needed on a regular basis just to maintain the current state of the decorative scheme - increasing the energy needed to carry out the work.		
	The NLHF grant also includes a far reaching community engagement programme that will feature talks, presentations, practical workshops for young people and families and the commission of a new artwork by Leeds based Pyramid of Arts. This will engage communities across the city and involve particinpants from different age groups and backgrounds.
