<p>Main aim An increase in demand for secondary school places has resulted in the need for additional places in the West of the city. Leeds West Academy took a bulge in September 2020 and 2021 ahead of a permanent expansion to a pupil admission number (PAN) of 300 from September 2022.</p> <p>Purpose A screening exercise has been carried out to determine if the proposals at Leeds West Academy will impact upon equality. The required building works will support the Authority’s legal duty to provide a school place for every child and, where possible, within the school of parental preference. The works consist of delivering 3 extensions to the existing wings of the building to create additional general teaching spaces and a science lab an expansion of the dining hall and servery area, a new all-weather pitch and an expansion of the existing changing rooms. The scheme will also create more staff parking on site and consider any off-site highways works that</p>

are needed because of the expansion.
