Executive Summary

To advise Members of an application for the certification of seven films in respect of the Leeds Palestinian Film Festival. All screenings are scheduled to take place between 20th November 2021 and 3rd December 2021, at HEART, Seven Artspace, Woodhouse Community Centre, Wheeler Hall, The Pyramid Theatre and Otley Courthouse.

Of the seven films to be certified, the applicant only has access to links for viewing four. Having sought legal advice, Members are recommended to certify the films they cannot view as category 18 ratings. Further information on this matter is detailed at 3.2 of this report.

1.0 Purpose of this Report

1.1 This report informs Members with the background, history and issues of an application made under the Licensing Act 2003 (“the Act”) for the certification of a film that does not currently have a BBFC (British Board of Film Classification) certification. Finally, this report informs Members of the options available to them when considering an application for the certification of films.

2.0 Background Information

2.1 The Licensing Act 2003 applies to premises which provide film exhibitions. At present there are a total of 8 cinemas licensed in the Leeds district.

2.4 A copy of the current BBFC Classification Guidelines are attached at **Appendix A** for Member's consideration.

3.0 Main Issues

3.1 An application has been received on behalf of Leeds Palestinian Film Festival for the certification of seven films scheduled for screening between 20th November 2021 and 3rd December 2021. The screenings are intended to take place at HEART, Seven Artspace, Woodhouse Community Centre, Wheeler Hall, The Pyramid Theatre and Otley Courthouse.

3.2 In response to a briefing by the BBFC and due to previous issues experienced with films that Members have been unable to view, the film classification process has now changed. Advice sought from the Council's Legal Department has reaffirmed it is essential the Licensing Sub-Committee can view each film in order to rate it appropriately. In instances where films are unavailable, Members are advised to certify them 18 rating, subject to a written declaration from the applicant confirming that each film does not contain any content which would more likely than not, render the film liable to be classified as R18 if considered in accordance with the BBFC Classification Guidelines.

3.3 A list detailing the title, synopsis and the applicant's suggested rating for each of the sevens films is as follows:

Title:	LITTLE PALESTINE (DIARY OF A SIEGE)

Screening Date:	1 st December 2021
Synopsis:	After the Syrian Revolution, Al-Assad's regime besieges the district of Yarmouk, the largest Palestinian refugee camp in the world. Yarmouk is cut off and out of the public eye. This filmed diary of the daily life of its inhabitants, who decided to face bombing, displacement and hunger with rallying, study, music, love and joy...

Title:	NOT JUST YOUR PICTURE

Screening Date:	3 rd December 2021
Synopsis:	Layla and Ramsis, German-Palestinian siblings living in Germany, face a family tragedy far away in the besieged Gaza Strip. A documentary feature by Anne Paq and Dror Dayan.

Synopsis:	This beautifully shot film captures how ordinary people find meaning behind the conflict in this small strip of land that borders the Mediterranean Sea.

3.5 Details of each film requiring classification have been provided to Members of the Licensing Sub Committee in advance of the hearing and a representative is due to attend the hearing to provide additional details.

4.0 Content Summary

5.1 To assist members with their deliberation, two officers of the Licensing Authority have viewed the films with available screeners and provided the following comments. These has been written by in accordance with BBFC guidelines.

5.2 Little Palestine, Diary of a Seige

The film is the heart-breaking tale of a community struggling to survive in increasingly difficult circumstances during the siege.

In the early stages of the film people are frustrated, but go about their lives. As the film progresses the town crumbles around them as buildings fall to mortar fire, but more critical is the food shortages resulting in distressing images of starvation. Despite the despair the film does not focus on misery, but of hope, with the documentary being realistic but never melodramatic.

In the context of what the message the film is conveying the officers that viewed it consider it is within the BBFC guidelines for a 15 rating.

5.3 Not Just Your Picture

The story of two German-Palestinian siblings who had their life shattered one morning in 2014 when their father, his second wife and their five young children were killed by an Israeli airstrike during the attacks on Gaza.

The film gives insight in to their emotions and attempts to visit their grieving family and the graves of their loved ones.

Officers consider this feature is within the BBFC guidelines for a 15 rating.

5.4 The Present

A short film documenting the troubles for Yusuf and his daughter to undertake a task taken for granted by so many.

The officers that viewed the feature consider it is within the BBFC guidelines for a 15 rating.

5.5 My Neighbourhood

A short film portraying a Palestinian teenager growing up in East Jerusalem where in some Palestinian neighbourhoods, Israeli settlers are securing court orders to evict residents and take possession of their homes.

Officers consider this feature is within the BBFC guidelines for a 15 rating.

6.0 Implications for Council Policy and Governance

6.1 There are no implications for Council policy and governance in respect of determining this application.

7.0 Legal and Resource Implications

7.1 The applicant can appeal any decision made by committee. Any appeal would be to the Magistrates' Court.

8.0 Recommendations

8.1 Members are requested to consider this request for the certification of the films as attached hereto.

8.2 Members are recommended to view films prior to the issue of a Certificate.

9.0 Options Available to Members

9.1 The Licensing Authority has the authority to categories a film which is absent of a Certificate from the BBFC.
