Fund will be made available to local authorities in England to support those most in need this winter, with the costs of food, fuel, water, and essential items. Leeds City Council has been allocated circa £7.1million to support vulnerable households between 6th October 2021 and 31st March 2022.

At least 50% of the total funding must be spent on families with children. In terms of type of support, the expectation is that the HSF should primarily be used to support households in the most need with food, energy and water bills. It can also be used to support households with essential costs related to those items and with wider essential costs. In exceptional cases of genuine emergency, it can additionally be used to support housing costs where existing housing support schemes do not meet this exceptional need. The funding can also be used to support families with food support in school holidays.

The Leeds Food Aid Network (FAN) brings different people, initiatives and institutions together who are involved in tackling food insecurity in the city. It includes Food Banks, FareShare, Food Drop In's/Soup Kitchens, Street Outreaches/Soup Runs, Parish/Food Pantries and certain forms of Social Enterprise.

In order to ensure as many people as possible are able to gain support for food and essential items through the Household Support Fund, it has been agreed that £150,000 of funding should be provided to the Leeds Food Aid Network (administered through Unity Poverty Action and Leeds Christian Community Trust). The Leeds Food Aid Network will distribute funding to a wide range of charities and third sector providers who have the established and trusted relationships with vulnerable families and individuals in the city, and who have worked throughout the pandemic to support people. This will ensure a wide range of the city's most vulnerable people receive assistance for food and essential items over the winter period.

The £150,000 of the Household Support Fund will be used to fund over 45 Leeds based organisations with grants of up to £4000 depending on scale and need. The charities and organisations have been identified Unity Poverty Action and Leeds Christian Community Trust in their role as chairing Leeds Food Aid Network. Charities and third sector organisations supporting the following groups or with specific remit listed below will receive funding support.

- Homeless and rough sleepers
- Migrants, Refugees and Asylum Seekers
- Families with children
- Church and faith based organisations
- Established food banks, soup kitchens and food distributors

In addition £15,000 will be allocated to for the purchase of Fuel Bank vouchers which will be distributed by a number of organisations city wide. A maximum of £10,000 will be allocated to administration. In total is is estimated that approximately 30,000 people will receive support.
