

(TRAFFIC REGULATION) (MOVEMENT RESTRICTIONS) (M1412) AMENDMENT NO.1 ORDER 2021; & (WAITING RESTRICTIONS) (W03) ORDER 2021 LEEDS PUBLIC TRANSPORT INVESTMENT PROGRAMME - A647 CORRIDOR STANNINGLEY

Leeds City Council proposes to make the above Orders under its powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce:

1. North-eastbound, with flow, Bus Taxi & Pedal Cycle Lanes; operating between 7.00am and 10.00am, and also between 4.00pm and 7.00pm (all days) on:

- **a.** A647 Bradford Road (north-westside carriageway nearside lane); from a point 130 metres north east of its junction with Sunnybank Lane, in a north easterly direction, for a distance of 175 metres.
- b. A647 Bradford Road (north-westside carriageway nearside lane); from a point 17.5 metres south west of its junction with Woodhall Lane, in a north-easterly direction, to a point 41.5 metres north east of its junction with Woodhall Park Drive (including the full extent of the nearside lane of the north eastbound cut through).

2. No Loading or Unloading at Any Time, on:

- a. A647 Bradford Road (north-west side); from a point 222 metres north east of its intersection with Moorland Road, in a north easterly direction for a distance of 106 metres
- **b. A647 Bradford Road** (south-east side); from a point 46.5 metres north east of its junction with Galloway Lane, in a south westerly direction for a distance of 112.5 metres.
- **c. Galloway Lane** (north-east side); from its junction with A647 Bradford Road, in a south easterly direction to a point 88 metres north west of its junction with Ederoyd Rise.
- d. Galloway Lane (south-west side); from its junction with A647 Bradford Road, in a south easterly direction to a point 90.5 metres north west of its junction with Moorland Road.
- e. Woodhall Lane (north-east side); from its junction with A647 Bradford Road, to a point 169 metres south east of its junction with Woodhall Park Grove.
- f. Woodhall Lane (south-west side); from its junction with A647 Bradford Road, in a northerly direction to a point 162 metres south east of its intersection with Woodhall Park Grove.
- g. Woodhall Lane (south-west side); from a point 123 metres south east of its intersection with Woodhall Park Grove, in a northerly direction to a point 102 metres south east of its intersection with Woodhall Park Grove.

3. No Loading or Unloading between 7.00am and 10.00am or between 4.00pm and 7.00pm; Monday to Friday (inclusive) on:

- a. A647 Bradford Road (north-west side); from a point 160.5 metres south west of Woodhall Park Drive, in a north easterly direction to its junction with Meadow Park Drive.
- b. A647 Bradford Road (north-west side); from its junction with Sunnybank Lane, in a north easterly direction to a point 222 metres north east of its intersection with Moorland Road.
- c. A647 Bradford Road (south-east side); from a point 46.5 metres north east of its junction with Galloway Lane, in a north easterly direction to a point 89.5 metres north east of its junction with Ederoyd Drive.
- d. A647 Bradford Road (south-east side); from its junction with Grange Avenue, in a north easterly direction to a point 215.5 metres north east of its junction with Moorland Road.
- e. Stanningley Road, Bramley (north-east side); from a point 11.5 metres west of its junction with Hough Lane, in a north westerly direction to a point 26 metres south east of its junction with Station Mount.
- f. Woodhall Lane (south-west side); from a point 162 metres south east of its intersection with Woodhall Park Grove to a point 123 metres south east of its intersection with Woodhall Park Grove.

3. No Waiting at Any Time, on:

- a. A647 Bradford Road (north-west side); rom a point 135 metres north east of its intersection with Moorland Road, in a north easterly direction for a distance of 193.5 metres.
- **b. A647 Bradford Road** (northern side); from its junction with the district boundary with Bradford, in a generally north-easterly direction, to a point 229 metres north east of its junction with of Sunnybank Lane.

- c. A647 Bradford Road (south-east side), from its junction with Grange Avenue, in a generally north easterly direction for a distance of 28 metres.
- d. A647 Bradford Road (south-east side); from a point 215.5 metres north east of its junction with Moorland Road in a north easterly direction, for a distance of 113 metres.
- e. Galloway Lane (north-east side); from its junction with A647 Bradford Road, in a south easterly direction, to a point 88 metres north west of its junction with Ederoyd Rise.
- f. Galloway Lane (south-west side); from its junction with A647 Bradford Road in a south easterly direction, to a point 90.5 metres north west of its junction with Moorland Road.
- g. Woodhall Lane (north-east side); from its junction with A647 Bradford Road to a point 169 metres south east of its junction with the projected south eastern kerb line of Woodhall Park Grove.
- h. Woodhall Lane (south-west side); from its junction with A647 Bradford Road, in a northerly direction, to a point 102 metres south east of its intersection with Woodhall Park Grove.

4. No Waiting between 7.00am and 10.00am or between 4.00pm and 7.00pm; Monday to Friday (inclusive) on:

- a. A647 Bradford Road (north-west side); from a point 8 metres north east of its junction with Woodhall Park Drive, in a north easterly direction, to a point 14 metres south west of its junction with Womersley Place.
- b. A647 Bradford Road (north-west side); from a point 28 metres west of its junction with Meadow Park Drive, in a south-westerly direction for a distance of 50 metres.
- c. A647 Bradford Road (north-west side); from a point 229 metres north east of its junction with Sunnybank Lane, in a north easterly direction for a distance of 206.5 metres.
- d. A647 Bradford Road (north-west side); from a point 28 metres south west of its junction with Woodhall Park Drive, in a south westerly direction for a distance of 132 metres.
- **e. A647 Bradford Road (**south-east side); from a point 5.5 metres west of its junction with Peckover Drive, in a south westerly direction, for a distance of 47.5 metres.
- f. A647 Bradford Road (south-east side); from a point 5.5 metres east of its junction with Peckover Drive, in a north easterly direction, for a distance of 12.5 metres.
- g. A647 Bradford Road (south-east side); from a point 28 metres north east of its junction with Peckover Drive, to a point 7 metres south west of its junction with Moorland Road.
- h. A647 Bradford Road (south-east side); from a point 7 metres north east of its junction with Moorland Road, in a north easterly direction. for a distance of 209 metres.
- i. A647 Bradford Road (south-east side); from a point 11 metres south west of its junction with Ederoyd Grove, in a south westerly direction, for a distance of 235.5 metres.
- j. A647 Bradford Road (south-east side); from a point 11 metres west of its junction with Ederoyd Drive, in a south westerly direction, for a distance of 43.5 metres.
- k. A647 Bradford Road (south-east side); from a point 6 metres north east of its junction with Ederoyd Drive, in a north easterly direction, for a distance of 30 metres.
- A647 Bradford Road (south-east side); from a point 28 metres north east of its junction with Grange Avenue, in a
 generally north easterly direction to a point 10 metres west of Daleside Road.
- m. Stanningley Road, Bramley (north-east side); from a point 11.5 metres west of its junction with Hough Lane, in a north westerly direction, to a point 26 metres south east of its junction with Station Mount.
