### **What is this report about?**

#### **Including how it contributes to the city's and council's ambitions**

- In March 2019, Full Council passed a resolution declaring a Climate Emergency.
- In May 2019, the then Leader of Council reviewed the Executive arrangements for the authority to reflect the Council's policy objectives in this area and the Climate Change Advisory Committee was established.
- CEAC is a cross party advisory committee authorised to consider and make recommendations regarding climate change and sustainability.
- The Scrutiny Board (Environment, Housing and Communities) received updates on progress towards the Council's climate change ambitions, along with the activity and work priorities of CEAC in September 2019 and February 2021.
- Members requested that the Scrutiny Board be kept updated on the progress of this work and the activity of CEAC given the Scrutiny Board's remit incorporates oversight of decision making relating to climate change, sustainable energy and carbon reduction.
- The Scrutiny Board is receiving the draft CEAC report in advance of its consideration at full Council in March 2022.
- Also attached to this item is the Annual Climate Emergency Report, which was provided to the Executive Board on 9 February.
