I object.

Firstly this is a residential area. Then I moved in 12 years ago the building [REDACTED] [REDACTED] was an office. They have always worked office hours, occasional deliveries but rarely outside office hours.

This will negatively effect the value of my property and the quality of my life. I would not have brought house knowing it would be next to such a place as is being proposed. Also I sleep at the [REDACTED] and it is currently quiet and peaceful. I assume that the changes will mean people coming and going well into the evening, talking, opening and closing car doors. I do not expect to be closing my windows at night to accommodate this change.
