# Approval to Use the Specialist Surface Treatment Works Yorkshire Highway Alliance Contract procured by Kirklees Metropolitan District Council.

## What is this report about?

## Including how it contributes to the city's and council's ambitions

- As part of collaborative working across the Yorkshire Highway Alliance (YHA), Kirklees Council have undertaken the procurement of a Framework Agreement for Specialist Surface Treatments Works available to the YHA which will be used to provide a range of specialist wearing course surface treatments
- This report seeks permission for Leeds City Council to use the YHA Specialist Surface Treatments Works Contract.

## Recommendations

- a) The Chief Officer (Highways and Transportation) is asked to approve the use of the YHA Specialist Surface Treatments Works Contract to 17 October 2023 with the provision to extend by 2 further 12-month periods until 17 October 2025.
- b) Leeds City Council estimates spending £1.3 million per annum through the contract.

## Why is the proposal being put forward?

- 1 To obtain the Chief Officer's approval to use the Contract procured by Kirklees Council.
- 2 As part of the YHA collaborative working group it was agreed that Kirklees Council would procure the Contract for the group members to use.
- 3 Procuring the contract as the YHA provides competitive rates and meets current guidance on the Highway Maintenance Efficiency Programme.
- 4 Kirklees Council have ensured that the procurement was carried out in accordance with the Public Contract Regulations 2015 and that the framework is available for Leeds to use.
- 5 Tenders have been evaluated and Kirklees Council have awarded the contract to 9 contractors. The Framework will be let for 2 years with the option to extend for a further two 12-month periods.

6 An equality, diversity, cohesion and integration screening has been carried out by Kirklees Council as part of their tender procedures and confirms that a full impact assessment is not required as the proposals are only seeking to use the YHA Specialist Surface Treatment Works Contract and will therefore have no impact on protected equality characteristics.

#### What consultation and engagement has taken place?

7 The service users across the West Yorkshire Districts and the Yorkshire Highway Alliance group members were consulted prior to the tendering process.

#### What are the resource implications?

- 8 Kirklees Council have undertaken a competitive tender exercise and the Contractors selected for the framework offer the best value.
- 9 Leeds City Council estimates spending £1.3 million per annum through the contract.

#### What are the legal implications?

10 This is a key decision and will be subject to call in as the value of goods that Leeds City Council will procure through this contract is estimated around £1.3 million per annum. This decision was published on the list of forthcoming Key Decisions on the 12 January 2022.

#### What are the key risks and how are they being managed?

11 Not approving the use of the Yorkshire Highway Alliance Contract would mean Leeds would have to procure a separate contract.

12 The contract is required to provide a range of specialist wearing course surface treatments which is used to maintain and improve the Cities infrastructure. This includes making the pavements and cycle paths safe for pedestrians.

13 The participation in this Contract is an efficient use of Council resources and will provide a cost-effective method of procuring these Specialist Surface Treatment Works.

#### b) How will success be measured?

14 Success will be measured over the life of the contract and how efficient the contractors are.
