Hello,

With regard to the review of the licensing arrangements of the above premises I would comment as follows;

I have been visiting this venue several times a week for the last couple of years and I am a little surprised to hear that there appears to be breaches of the conditions mentioned in the notice displayed outside the premises. I accept that I am only a paying customer and have no official connection with the establishment but I would be very sad to see any curtailment of their ability to continue to operate.

The staff, some of which have worked there in previous incarnations, are delightful and highly experienced, efficient and a pleasure to be served by. They know what is required, and acceptable, on licensed premises.

I have never seen any antisocial behaviour that I can recall and all the people I have met in there, that I didn't know, seem to just be having a good time.

It has been a very difficult period for a fledgling business during the last couple of years because of the pandemic but I have seen at first hand the attempts they have made to try and make it succeed, not always in the right way in my personal view. However, I'm not a business person either. The table tennis table is not seen in too many establishments and proved incredibly popular. Even I gave it a go even at my age [REDACTED]

What I do know is the loss of this location as a social venue would be sorely felt. There are very few other locations remaining in the area these days and access to them may well require transport if you require assistance. That comes at a cost that these days one may not be able to afford.

As indicated above it has been a difficult time for them but having got through winter, with a summer to look forward to, I would hope that things would improve for them and whatever issues they are facing will be addressed. The alternative would be a loss.
