2. Please provide a brief description of what you are screening

The Combined Authority are responsible for preparing and managing Car Club in West Yorkshire and York. Internal sign off by the Combined Authority is currently being undertaken alongside approval by Districts.

Car clubs are recognised as a demand management measure to reduce overall car dependence, encourage use of more sustainable modes of travel and provide for urban mobility needs.

The Leeds Transport Strategy makes direct reference to car clubs and their role in reducing private car ownership but still enabling people to travel by car when necessary. Car club use brings additional benefits such as improved air quality due to reduced

congestion and private car ownership, as well as promoting more active travel. Enterprise will operate a Back-to-Base business model meaning that the vehicles operate from fixed locations, have to be reserved in advance and must be returned to the same location.

Enterprise Car Club offer a range of hybrid and electric vehicles. The car club will have the greatest benefit for those who can drive and who do not currently have access to a vehicle and whose mobility is constrained by lack of public transport options.
