On 24 March, the Department of Health and Social Care (DHSC) published guidance on the Market Sustainability and Fair Cost of Care Fund 2022/23 to support local authorities to prepare their markets for reform and move towards paying care and support providers a fair cost of care. Local authorities are required to complete cost of care exercises and an initial Market Sustainability Plan and spend returns, which they have to submit to DHSC by 14 October 2022, as a condition of receiving future funding. A full Market Sustainability Plan is required for submission in February 2023. Additional staffing capacity is required to undertake the work within the tight timeframes.

The request is to establish two temporary posts, PO4 FTE and a C1 P/T 18.5hrs for an 18-month period within the Integrated Commissioning Team.
