- A wide-ranging needs assessment relating to domestic violence and abuse has been undertaken (included demographic data, views from service providers and views from victims-survivors of abuse). Findings from this exercise informed the service delivery which will be funded through these proposals.

<ul style="list-style-type: none"> • Key findings (think about any potential positive and negative impact on different equality characteristics, potential to promote strong and positive relationships between groups, potential to bring groups/communities into increased contact with each other, perception that the proposal could benefit one group at the expense of another) • The proposals include the continuation of additional specialist domestic violence support into community-based accommodation, with a particular focus on people who have protected characteristics and are under-represented at seeking support for domestic abuse. The team includes workers from a range of community-based organisations who, in addition to providing casework, are raising awareness within their communities about domestic violence and the support that is available.
