Decision to award a contract to Link Maker for Link Maker Adoption Matching Licence.

The web-based Link Maker matching service provides a national database of children and families accessible to adoption social workers and approved adopters. The system serves to increase placement choice for children awaiting adoption through creating access to a UK-wide pool of available adopters. The service includes registration to an online portal, which assists in finding prospective adopters for children and young people. This service is only available under licence. The provision of the Link Maker matching service assists OAWY in ensuring children and young people are matched with prospective adopters able to meet their needs in a timely way.

There is an existing licence with Link Maker for these services which is due to expire. No impact as no change resulting from this decision.
