New merchants will provide LBS with materials following this procurement. The procurement will result in a change of existing materials provider only with no negative impact upon EDCI.

New contracts will support advancing equality of opportunity via social value outcomes. LBS is working with Procure Plus, a not-for-profit, social value organisation which will redirect half of its proceeds into Leeds through the delivery of social value objectives. LBS will work in close partnership with Procure Plus to ensure that money is directed at those residents and areas with the highest priority need for example care leavers and long-term unemployed. We estimate that this procurement will create up to 15 new employment outcomes for those furthest from the labour market across the lifetime of the contracts.
