Officers working within the partnership structures that are in place to support high-risk victims-survivors of domestic abuse - Daily Risk Assessment Meetings (DRAM) and

Multi-Agency Risk Assessment Conferences (MARAC) - routinely collect and analyse demographic information relating to people being referred for support.

#### Key findings

Officers identified a gap in specialist support for 2 cohorts of victims-survivors of domestic abuse:

This funding has been received following a bid to the Ministry of Justice – it is additional money into Leeds and will therefore not negatively impact on other victims-survivors – in fact all groups will benefit because the existing IDVAs will now be able to support more people.
