## **What is this report about?**

### **Including how it contributes to the city's and council's ambitions**

This report provides an overview of the work of the Fostering Service during the last year, as a Service we are required to report on and publish our activity on an annual basis.

Operating the service during the last year has been against a context of the global pandemic which has had an impact, we have seen an increase in the number of looked after children, both here in Leeds and other key areas in the United Kingdom. Whilst recruitment has continued, it has not been at the pace of previous years and we have seen a net decrease in the number of carers. Recovery and building back resilience will be critical in the coming year.

The report references some of the key elements which have supported the service over the last year and will support growth and development going forward. There is now a permanent Service Manager in post, and depth and expertise across the staff teams. Four Fostering Panels run each month to ensure timely approval of carers. Blended training programme offered throughout the year, with a full and robust training offer in place for this year. Enrichment activities have now resumed. Support groups have continued throughout the year and now returned to being in person. The ongoing high use of Kinship carers supports children to remain with their birth families where it is safe to do so. Mockingbird Family Model is key to effectively supporting carers and maintaining placement stability, continue to have 10 hubs with a view to establishing an 11th this year.

The Fostering Children with disabilities team continues to provide short- and long-term specialist care for eligible children. Whilst the Support Care Scheme continues to be part of the preventative support that can seek to prevent children becoming looked after.

Placement stability and effective outcomes for children and young people is more likely to be achieved when we place children and young people in their home area with Leeds carers and this is the key driver to building an effective local authority fostering service.

Specifically:-

- The Leeds City Council Fostering Service is registered with OfSTED and regulated under the National Care Standards Act 2000 and Fostering Regulation, 2011, and National Minimum Standard for Fostering.

- This report provides an overview of the work of the Fostering Service during the 2021/22 financial year.
- Leeds City Council is committed to all children who are looked after living in a family context where ever possible. Where a child's family are unable to offer care for a child, a child maybe placed with a foster family. The Fostering Service is responsible for ensuring that foster families are recruited, supported and enabled to care for children in the care of Leeds City Council.
