## 2. Please provide a brief description of what you are screening

As part of the System Flow programme, a Transfer of Care Hub has been developed in Leeds Teaching Hospital Trust, St James University Hospital site. Developed as part of the Alliance between Leeds City Council and Leeds Community NHS Healthcare Trust it is a multi-disciplinary team. The multi-agency team have identified tasks that the identified health case manager staff could undertake on behalf of the Local Authority in carrying out the duties under the Care Act 2014. These tasks are defined as delegated duties. The Delegated Duties Agreement outlines the specific tasks, the specific roles that are to undertake them and how the agreement will be managed, reviewed and effectively governed. Responsibility sits with the Director of Adults and health and the Alliance Board.
