a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

The premises has been assessed against the 4 Licensing Objectives as low risk

- 1: A tamper-proof digital colour CCTV system to be installed and maintained on the premises
- 1.1 CCTV footage will be retained for a minimum of 31 days.
- 2. There will; be minimum number of 40 covers.

b) The prevention of crime and disorder

- 3: The CCTV system will provide a clear head and shoulders view to an evidential quality on the customers entry.
- 3: Record footage will be provided within a reasonable time to a police constable upon request.
- 4. Such footage will be provided in a viewable format and to include any software etc. that is required to view the footage.
- 5. The Designated Premises Supervisor will ensure that the CCTV system is checked at least once every month. This check will include the operation of the cameras, the recording facilities, the facilities for providing footage and the accuracy of the time and date. A written record of these checks to be kept on the premises and made available to a police constable within a reasonable time upon request.
- 6. Alcohol will only be sold or supplied to diner's ancillary with food orders, unless waiting for a table.
- 7. A contact number for the Designated Premises Supervisor will be available on the premises when not on duty.
- 8. Relevant staff will be given the appropriate training on the legislation relating to alcohol and diners under the age of 18.
- 8.1 An Alcohol register containing all the names of all persons who are authorised to sell alcohol on the premises will be completed and kept at the premises for a minimum of 12 months.

d) The prevention of public nuisance

Noise

- 9. Prominent, clear and legible notices will be displayed at the exit and in key areas, requesting the public to respect the needs of the local residents and to leave the premises and the area quickly and quietly.
- 10. All residents of the flats above the premises shall be given the number of the Duty Manager in case of any issues regarding noise nuisance.
- 11. No waste to be disposed of between the hours of 20:00 and 08:00 every day.
- 12. The hours of deliveries and supplies to the premises and collection of refuse shall be restricted to 09:00 and 18:00 hours Monday to Saturday with no such operations on Sundays and Bank Holidays.
- 13. A noise limiter shall be fitted to the Music amplifier System and no loud music to be played after 23:00 on Fridays and Saturdays.
- 14. No live music to be played at the venue at any time.
- 15. The Management will provide a free telephone service for all non residents and will have an agreement with a local taxi company that will agree to certain 'quiet' conditions when collecting customers at the end of the evening. These quiet conditions will ensure that all taxis vehicles will make the minimum noise possible and encourage customers to leave quickly and quietly.
- 16. All customers shall be encouraged to pre-book taxi's and to wait for their taxi's inside the restaurant area.

e) The protection of children from harm

Compliance Logs

- 16. A written register of refusals will be kept including a description of the people who have been unable to provide required identification to prove their age. Such records shall be kept for a period of 12 months and will be collected by the designated premises supervisor and produced to the police or an 'authorised person' (as defined by section 13 of the licensing act 2003) or an authorised trading standards officer the local authority/council on demand.
- 17. All staff engaged in the sale of alcohol shall be trained in Challenge 25. Training records shall be kept on the premises and produced to the police or an 'authorised person' (as defined by section 13 of the licensing act 2003) or an authorised trading standards officer of the local authority/council on demand

18. Challenge 25

- **18.1** The premises shall operate a Challenge 25 policy. Such policy shall be written down and kept at the premises. The policy shall be produced on demand of the police or an 'authorised person' (as defined by section 13 of the licensing act 2003) or an authorised trading standards officer the local authority/council.
- **18.2** Prominent, clear and legible Challenge 25 signage shall also be displayed at all entrances to the premises as well as at, at least one location behind any counter advertising the scheme operated.
- **18.3** Proxy signs will be fitted near to all alcohol P.O.S positions warning people not to buy alcohol for children.
