I am wanting to raise an objection to the Application from the owners of Shimlas at 293 Roundhay Road for an extension of their opening hours due to the following reasons:

- I have received multiple complaints from local residents
- Noise nuisance for local residents – I am extremely concerned about the Application to open Shimlas until 3.00am Monday to Saturday and 2.00am on Sundays as I feel this will affect local residents and families
- As there is very limited parking for customers of Shimlas, customers are parking on local streets and sometimes on the pavements blocking pedestrian access
- Shimlas is situated on an already very busy junction making the junction more dangerous/increasing the risk of road traffic and pedestrian accidents (there have been some serious accidents at this junction)
- The noise nuisance, parking issues and potential antisocial behaviour created by late night Shimla customers is a threat to the local community and affects all local streets including Harehills Lane, Harehills Avenue and Brookfield Avenue (to the rear of Shimlas) as well as others.
- I am also aware that during the first 4 – 6 weeks of first opening, Shimlas were staying open well beyond the times they should have been officially closed which shows the business has a history of failing to follow the rules.

In view of the above I would like to formally object to Shimlas Application to extend their opening hours.

As this shop falls within the boundaries of our ward, all three councillors object to this application. The shop falls on one of the busiest roads and at the corner of a very busy junction. The opening of this shop until 3am invites further ASB and a floodgate of similar applications being made by other shops on the busy road. The premises has no designated parking which means vehicles will be parking in back streets to visit the premises. This again invites ASB on these streets which will lead to angry residents. The shops near to Shimlas are already complaining of the lack of parking there is available to their customers as people who go to Shimlas park outside the parade of shops near to it.

I a resident of Harehills, Leeds, and object to Entertainment Licensing Leeds City Council to allowing the application under section 17 of part 3 of the Licensing Act 2003 for the grant of a premises licence for the premises known as Shimla's, Leeds of 293 Roundhay Road, Leeds, LS8 4HS.

I am a resident of Harehills, Leeds and also a Hackney Carriage Driver by profession, I object to the application on the basis that these premises are located on a very busy junction, as my job entails me picking up and dropping off fares in and around the area of these premises, I am somewhat perplexed at how this location was even allowed planning permission for a restaurant .

If anyone from the entertainment licensing team was to actually spend any time around the actual area during the normal opening hours of this establishment, it would be clear to them that due to the location of the premises, it is highly unsafe/dangerous to allow such an establishment to trade from these premises.

I have on many occasions had to avoid members of the public leaving the establishment and crossing into the path of my vehicle, also the area in the evenings is now congested with vehicles parked on public footpaths making pedestrians walk onto the road to pass the illegally parked vehicles.

I can only say that if the hours were to be extended it would at some point result in a serious accident or fatality in and around the area due to the location as well as an increase in anti social behaviour.

Dear Sirs,

I write to you in respect of the above matter, as a resident of Roundhay and as a business owner in Harehills.

I can confirm that I am the proprietor of [REDACTED]

You may also be aware that we nearly spent 5 years obtaining permission from the Council to allow our patrons to park outside our premises for a period of 30 minutes.

Our opening hours are from 09.00 am to 08.00 pm in the evening 7 days a week, we have parking at the front of our premises and also at the rear of the premises.

Since Shimla's has opened on Roundhay Road, we have had a large number of patrons of Shimla's parking inconsiderately at both the front and rear of our premises, this has impacted on our customers not being able to stop and park outside our premises.

I have also noted that all the commercial premises located between myself and Shimla's are having the same issue, in that patrons of Shimla's are parking inconsiderately outside all the premises.

This is having a negative effect on the area as a whole as along with the inconsiderate parking, anti social behaviour is taking place around the area, above my premises i have three flats rented out to family's, who have since the opening of Shimla's complained to me of anti social behaviour in and around the area at night.

I would like to state at at this point that next door to my premises is a restaurant namely, [REDACTED], this restaurant has been established for some time now and is right next door to my premises, however the clients that frequent this restaurant have never caused our business or the family's living above our premises any issues, the cliental that visit Shimla's have caused us much aggravation in the form of inconsiderate parking and anti social behaviour.

I therefore strongly oppose any application to extent the hours and would request that Leeds City Council review the actual hours they have at present.
